NOTICE OF SATISFACTION AND RELEASE OF INFRASTRUCTURE OBLIGATIONS (Conditional Annexation and Zoning Agreement for South Ridge)

This Notice of Satisfaction and Release of Infrastructure Obligations (Conditional Annexation and Zoning Agreement for South Ridge) ("Notice of Satisfaction and Release") is made and entered into this 29 day of June, 2017, by the City of Lincoln, Nebraska, a municipal corporation ("City").

RECITALS

I.

On February 14, 1994, the City entered into the Conditional Annexation and Zoning Agreement for South Ridge with Ridge Development Limited Partnership, a Nebraska limited partnership, Lincoln Memorial Park Cemetery Association, a Nebraska corporation, Zermatt Equity Corporation, a Nebraska corporation, R. C. Krueger Development Company, Inc., a Nebraska corporation, and Robert A. Witt, a married person and Paul K. Witt, a single person (collectively "Property Owners"), which was subsequently amended by the First Amendment of the Conditional Annexation and Zoning Agreement for South Ridge entered into between the City and the Property Owners (or successors thereto) on August 4, 1995, and filed of record with the Lancaster County Register of Deeds as Instrument No. 97-000810 (collectively "Annexation Agreement").

II.

The Annexation Agreement identified municipal infrastructure improvements necessary to serve and properly accommodate the proposed annexation and uses under the proposed zoning

of the East Area, defined therein, and the City's and Property Owners' responsibilities regarding said infrastructure improvements.

III.

The Property Owners' obligations relating to the necessary municipal infrastructure improvements identified in Section II of the Annexation Agreement have been fully satisfied and the City desires to evidence said satisfaction with a written release.

NOW, THEREFORE, in consideration of the above recitals and mutual covenants contained herein, the City agrees as follows:

- 1. The City acknowledges and gives notice that the Property Owners have fully satisfied the Property Owners' obligations contained in Section II of the Annexation Agreement, including, but not limited to, obligations relating to construction of or contribution to the cost of constructing and dedication of easements and right-of-way for Sanitary Sewer, Water Mains, Streets, Sidewalks, and Parks and other necessary municipal infrastructure improvements contained in Section II of the Annexation Agreement. In consideration for said satisfaction, the City hereby completely, finally and forever releases and discharges the Property Owners and the East Area from any and all obligations contained in Section II of the Annexation Agreement.
- 2. This Notice of Satisfaction and Release shall inure to the benefit of the Property Owners and shall run with the East Area, which is identified on <u>Exhibit "A"</u> attached hereto and incorporated herein by this reference.
- This Notice of Satisfaction and Release shall be effective upon its execution by the
 City.
