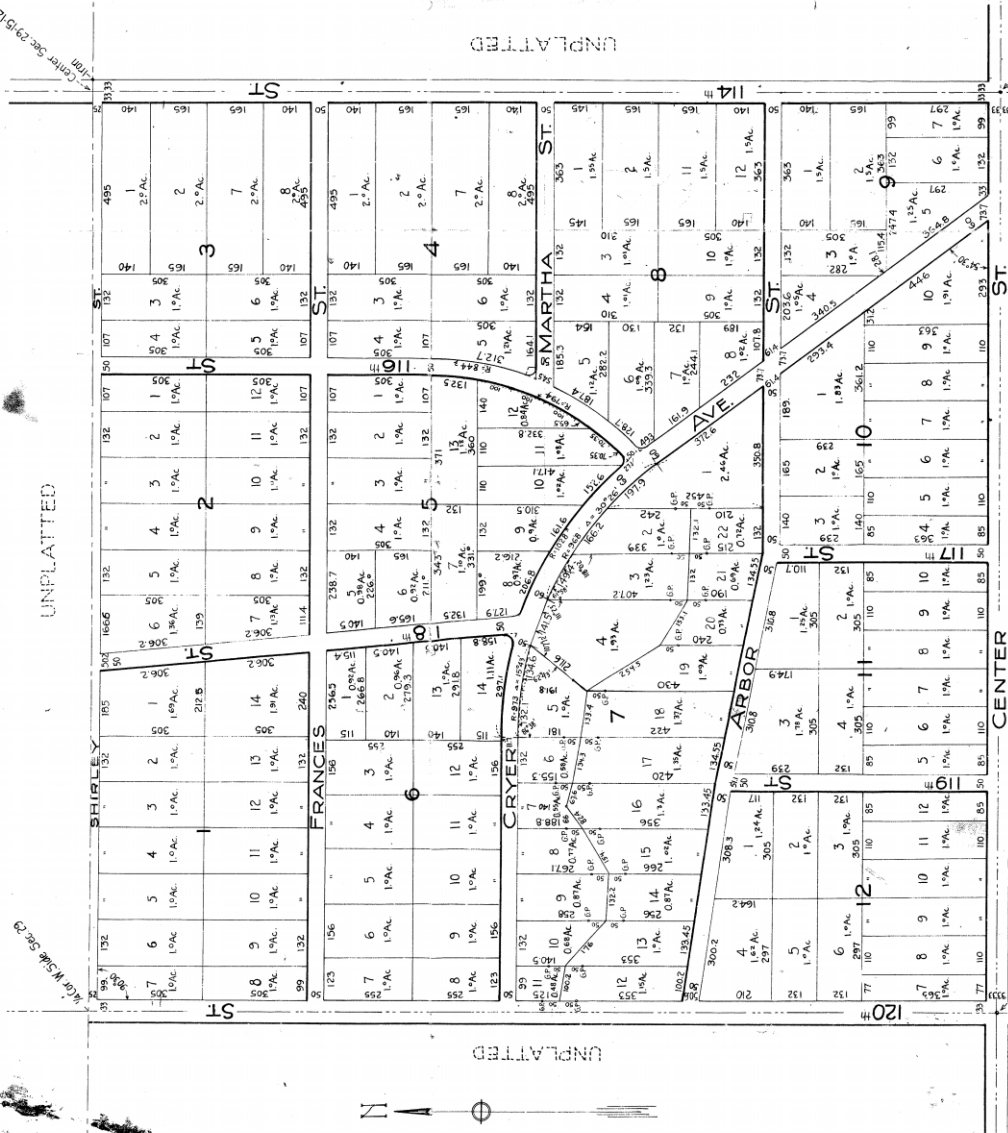


# HAPPY HOLLOW VIEW
