ON COMPANIENT TO PROTECTIVE COVENANTS

WHEREAS, protective covenants were filed on October 11, 1941, at 11:45 A.M., in the office of the Register of Deeds in Douglas County, Nebraska, covering certain properties in the Townsite of Ralston, Douglas County, Nebraska, and which were recorded in Book 160, Miscellaneous Records, Page 165, and which covenants provided in part:

"No building shall be located on any of these lots nearer than 25 feet to the front lot line";

and

WHEREAS, all houses on said lots were in process of construction at the time said covenants were filed: and

WHEREAS, because of existing construction on adjoining lots, it was deemed inadvisable and improper to use a minimum set back line of twenty-five feet;

No building shall be located on Lots 37, 38, 39, and 40, Block 41 in the Townsite of Ralston, Douglas County, Nebraska, nearer than 24 feet to the front lot line.

No building shall be located on the $17\frac{1}{2}$ foot strip adjoining on the south and Lots 9, 10 and 11 in Block Twenty-seven (27), in the Townsite of Ralston, Douglas County, Nebraska, nearer than 15 feet to the front lot line.

No building shall be located on Lots 1, 2, 3, and 4, except the Noth Fifty feet thereof in Block Thirty-Nine (39) Townsite of Ralston, Douglas, County, Nebraska, nearer than 24 feet to the front lot line.

No building shall be located on the North 50 feet of Lots 1, 2, 3, and 4 in Block 39 in the Townsite of Ralston, Douglas County, Nebraska, nearer than 24 feet to the front lot line.

No building shall be located on the South One-Half (S^{1}_{2}) of Lots 21 and 22 in Block 23, in the Townsite of Ralston, Douglas County, Nebraska, nearer than 17 feet to the front lot line.
