AN ORDINANCE OF THE CITY OF WAVERLY TO ANNEX ALL OF RILEY ADDITION AND IRREGULAR TRACTS 67, 71, 72, AND 73, AND AMBERLY ROAD ADJACENT THERETO.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF WAVERLY, NEBRASKA:

Section 1. Whereas, the following described real estate, to wit:


