It is the intention of the parties that this Easement will convey a right of ingress and egress for the purposed unrestricted drive to U.S. Highway No. 30; that this conveyance opens the control of access for the above described 40.0 feet; and that the control of access remains unchanged except for the elimination of a field entrance located 381.3 feet southwesterly from the East Line of said Northwest Quarter, said field entrance being on the northwesterly side of said highway and except for the unrestricted drive described in this conveyance.

That this easement for ingress and egress conveyed herein by the State of Nebrasika shall be used only for the purposes set forth herein, and upon abondoment of such usessail be void and cause such right of ingress and egress to revert to the grantor.
