BANKRUPTCY TRUSTEE'S DEED

This Deed is made this 30th day of June, 2006, by Thomas D. Stalnaker, as Trustee of the Estate of Saddlebrook Properties, LLC, entitled <u>In re Saddlebrook Properties</u>, <u>LLC</u>, <u>BK</u> 06-80249, as Grantor, and First National Bank of Omaha, a National Banking Association, as Grantee.

Recitals

WHEREAS, an Order for Relief under Chapter 11 of Title 11 of the United States Code was entered against Saddlebrook Properties, LLC, by the United States Bankruptcy Court for the District of Nebraska upon Voluntary Petition filed March 8, 2006; and

WHEREAS, on March 29, 2006, Thomas D. Stalnaker was duly appointed Trustee of the Estate of Saddlebrook Properties, LLC; and

WHEREAS, Trustee, in accordance with applicable Bankruptcy Rules, provided all creditors and other parties-in-interest with notice of intent to sell property pursuant to 11 U.S.C. § 363 upon Motion filed with the United States Bankruptcy Court for the District of Nebraska on May 18, 2006, and upon the Notice Setting Objection/Resistance Deadline; and

WHEREAS, after notice and hearing, the United States Bankruptcy Court for the District of Nebraska had entered an Order on June 2, 2006, approving the sale of the Debtor's assets at public sale, which sale was duly held on June 22, 2006.

NOW, THEREFORE, know all by these presents, that I, Thomas D. Stalnaker, Trustee, as Grantor, by virtue of the power and authority vested in me, as aforesaid, in consideration of the sum of Two Million Two Hundred Eighty-eight Thousand Three Hundred Fourteen and 54/100ths Dollars (\$2,288,313.54), paid by the Grantee, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell and convey unto First National Bank of Omaha, a National Banking Association, Grantee, its successors and assigns forever, all of Grantor's right, title and interest in and to the following described real estate:
