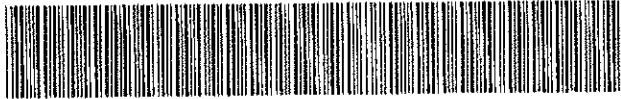

PARTIAL RELEASE OF EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that QWEST CORPORATION, a Colorado Corporation (F.K.A. A STRIP OF LAND TEN FEET (10') IN WIDTH, BEING FIVE FEET (5') EACH SIDE OF AND ABUTTING THE COMMON SIDE LOT LINES OF LOTS SEVEN (7) AND EIGHT (8) AND THE COMMON LOT LINES OF LOTS EIGHT (8) AND NINE (9), ALL IN SKYLINE MEADOWS AND NOW KNOWN AS LOTS ONE (1) THROUGH THREE (3) OF SKYLINE MEADOWS REPLAT 1, AS SURVEYED, PLATTED AND RECORDED IN DOUGLAS COUNTY, NEBRASKA.

Said Plat and Dedication of Skyline Meadows was filed for record January 2, 1996, in Book 2022, Page 512 in the office of the Register of Deeds of Douglas County, Nebraska.

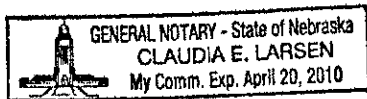
