DEED OF TRUST AND CONSTRUCTION SECURITY AGREEMENT AND FIXTURE FINANCING STATEMENT

THIS DEED OF TRUST AND CONSTRUCTION SECURITY AGREEMENT AND FIXTURE FINANCING STATEMENT ("Deed of Trust"), dated as of November 19th, 2014 among Sandy Pointe Lake Development, LLC, a Nebraska limited liability company (the "Borrower" or "Trustor"), R.J. Shortridge, Esq, a duly authorized member of the Nebraska State Bar Association ("Trustee"), and SPL Financing, LLC, a Nebraska limited liability company (the "Lender" or "Beneficiary");

WITNESSETH:

WHEREAS, the Trustor is the owner of certain Land (as hereinafter defined) located in the County of Saunders, State of Nebraska; and

WHEREAS, there are or will be located upon the Land certain Improvements, Fixtures and Equipment (as hereinafter defined); and

WHEREAS, to finance temporarily a portion of the cost of the Land, Improvements, Fixtures and Equipment, the Trustor has entered into a Construction Loan Agreement (as hereinafter defined, which Construction Loan Agreement is hereby incorporated herein by reference) with the Beneficiary, whereby the Beneficiary has agreed, among other things, to loan to the Trustor an amount not to exceed Eight Million and 00/100 Dollars (\$8,000,000.00) (the "Loan"), which shall be evidenced by a promissory note (together with any amendment, modification, extension, renewal or replacement thereof, the "Note"), of equal amount, bearing interest at a rate per annum equal to three and one-half (3.5%), subject to adjustment as provided in the Note; and

WHEREAS, the Beneficiary has required, as a condition of making the Loan, that the Trustor secure the Note and its obligations under the Construction Loan Agreement by this Deed of Trust.

GRANTING CLAUSES

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, THIS DEED OF TRUST WITNESSETH:

The Trustor, in consideration of the making of the Loan by the Beneficiary to the Trustor, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Trustor does hereby irrevocably grant, bargain, sell, convey, mortgage, grant a security interest in and pledge unto the Trustee, its successors and assigns, IN TRUST WITH FULL POWER OF SALE, forever, the following:

- A. The Trustor's entire estate and interest in the Land;
- B. The Trustor's entire estate and interest in and to the Improvements, all materials or supplies now or hereafter located on the Land which are intended to be incorporated in the Improvements that are owned by the Trustor, and all tenements, hereditaments, appurtenances, rights, privileges, and immunities thereunto belonging or appertaining;
