AMENDMENTS TO PROTECTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, being the owners of all of the lots in Sarpy Heights, a Subdivision as surveyed, platted and recorded in Sarpy County, Nebraska, do hereby make the following amendments to the Protective Covenants heretofore adopted, which Protective Covenants are recorded in Book Misc. 37 at Page 451 of the records in the office of the Register of Deeds of Sarpy County, Nebraska.

Said covenants heretofore adopted are amended by amending Section 17 thereof to read as follows:

All dwellings in the Subdivision must be connected to the existing water system. No private wells, except irrigation wells, may be installed within the boundaries of said Subdivision,

and by adding thereto Paragraph 18, as follows:

As to Lots 202 and 203 of said Subdivision which are a re-plat of Lots 25, 26, 27, 28, 29, 30, 31, 32 and 45, it is provided as follows:

Said Lots shall comply with Section 4 of the Sarpy County Zoning Regulations, which Section permits two horses on each lot, plus one acre for each additional horse. Provided, that said horses shall be stabled and maintained on the east two-thirds of said lots.

This paragraph shall supercede paragraph 12 above so far as the two paragraphs shall be conflicting.

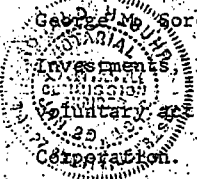
