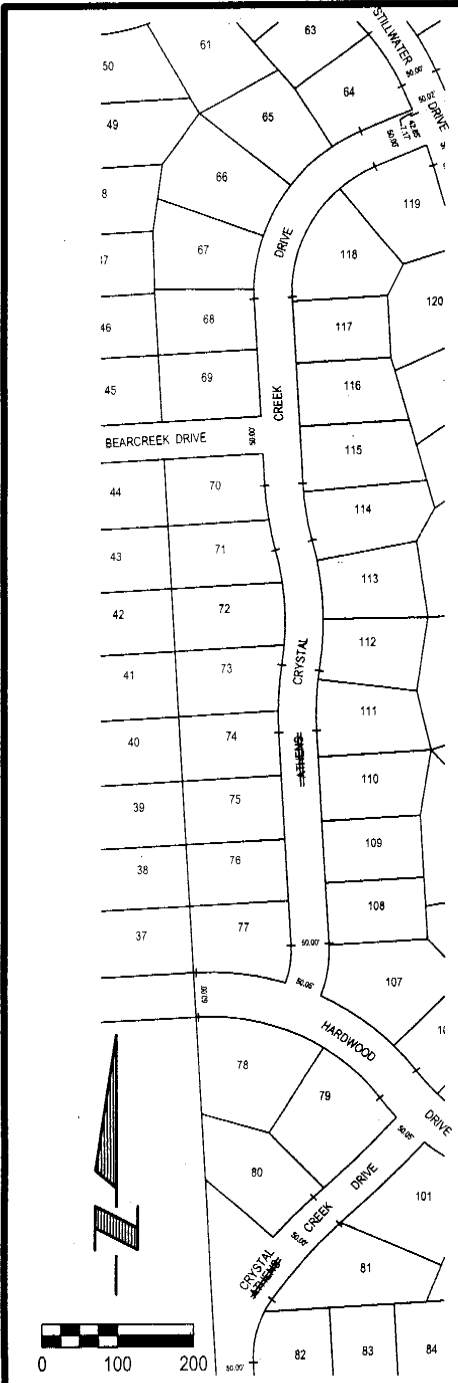

The street name to read Crystal Creek Drive instead of Athens Drive.

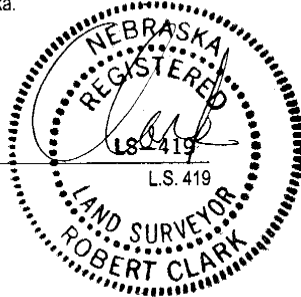
