KNOW ALL MEN BY THESE PRESENTS, that OMAHA PUBLIC POWER DISTRICT, a public corporation, for and in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby release and disclaim any rights it may have attained by virtue of the plat and dedication of Schwalb's 5th & 6th addition, an addition to Douglas County, Nebraska as surveyed, platted and recorded over, upon, along and above the following described property:

A Ten foot (10') strip of land being Five feet (5') each side of and abutting the common lot lines of lots Six (6) and Seven (7), Seven (7) and Eight (8), Eight (8) and Nine (9), Nine (9) and Ten (10) of Schwalb's 5th Addition. Together with a Ten foot (10') strip of land being Five feet (5') each side of and abutting the common lot line of Ten (10) Schwalb's 5th addition and lot One (1) Schwalb's 6th addition, along with the common lot lines of lots One (1) and Two (2), Two (2) and Three (3) of Schwalb's 6th Addition.

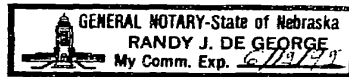
