and said owners have previously granted an access easement benefiting certain neighboring properties, described herein as Parcels 1 and 3, which easement is described as follows:

The North 4 Feet of the south 100 Feet of the West Thirty Feet of Lot Ten (10), Block Seven (7), Second Hillsdale Addition, Lincoln, Lancaster County, Nebraska (hereinafter described as "Easement 2").

JOHN H. DALAO and EVELYN L. DALAO, Husband and Wife, are the owners of record holding fee simple title to the following described property:

North 42 Feet of Lots Nine (9) and Ten (10), except the South Five (5) Feet of the North 42 Feet of the East 20 Feet of Lot Ten (10), and the South one-half of the alley adjacent to the north, Block Seven (7), Second Hillsdale

Addition, Lincoln, Lancaster County, Nebraska (hereinafter described as "Parcel 3").

and said owners have previously granted an access easement benefiting certain neighboring properties, described herein as Parcels 1 and 2, which easement is described as follows:

The North 4 Feet of the South 104 Feet of Lots Nine (9) and Ten (10), Block Seven (7), Second Hillsdale Addition, Lincoln, Lancaster County, Nebraska (hereinafter described as "Easement 3").

The above described owners of Parcels 1, 2 and 3 now wish to make additional agreements pertaining to Easements 1, 2 and 3 (hereinafter referred to together as the "Easement Area").

The owners of Parcels 1, 2 and 3 agree as follows:

- 1. Maintenance of the Easement Area for access purposes shall be shared equally by the owners of Parcels 1, 2 and 3, one-third allotted to each Parcel. The owners of the Easement Area acknowledge a duty to maintain the Easement Area in a reasonable condition for its intended use of access to garage facilities. *
- 2. Maintenance decisions must be agreed upon by the owners of all three Parcels.
- 3. Each owner shall be solely responsible for any damage caused by his or her own negligence or the negligence of his or her invitees or agents.
- 4. The Easement Area shall be used for access purposes only and for no other purpose and the owners of Parcels 1, 2 and 3 shall not block the access of any person having a right to use the Easement Area.
- 5. This Easement and the agreements herein and shall be construed as covenants running with the land and shall be binding on the successors and assigns of the parties.
