REFERRING TO THE SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF SAID SECTION 30; THENCE NORTHERLY ALONG THE WEST LINE OF THE SOUTHEAST QUARTER A DISTANCE OF 49.415 METERS (162.12 FEET); THENCE EASTERLY DEFLECTING 89 DEGREES, 51 MINUTES, 22 SECONDS RIGHT A DISTANCE OF 77.277 METERS (253.53 FEET) TO THE POINT OF BEGINNING; THENCE EASTERLY DEFLECTING 08 DEGREES, 21 MINUTES, 25 SECONDS LEFT A DISTANCE OF 101.295 METERS (332.33 FEET); THENCE EASTERLY DEFLECTING 21 DEGREES, 21 MINUTES, 46 SECONDS RIGHT A DISTANCE OF 65.419 METERS (214.63 FEET); THENCE WESTERLY DEFLECTING 166 DEGREES, 59 MINUTES, 39 SECONDS RIGHT A DISTANCE OF 163.960 METERS (537.93 FEET) TO THE POINT OF BEGINNING, CONTAINING AN AREA OF 0.120 HECTARES (0.30 ACRES) MORE OR LESS.

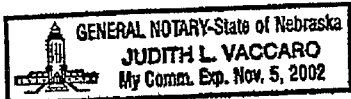
