



EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That **Lola H. Sievers Living Trust**, herein called "Grantor", whether one or more, record owner of the real property hereinafter described, for and in consideration of the sum of **One Dollar ( \$1.00 )**, duly paid, the receipt whereof is hereby acknowledged, and the further consideration of the performance of the covenants and agreements by Grantee as hereinafter set out and expressed, does hereby GRANT, REMISE and RELINGQUISH unto the City of Lincoln, Nebraska, a municipal corporation, its successors and assigns, herein called "Grantee", the RIGHT, PRIVELEGE and EASEMENT to construct, reconstruct, maintain, operate, and replace **Storm Sewer**, and appurtenances thereto belonging, over and through the following described real property, to-wit:

A portion of Lot 73 I.T., located in the Northeast Quarter of Section 36, Township 9 North, Range 6 East of the Sixth Principal Meridian, Lancaster County, Nebraska. Beginning at the Northeast corner of said Lot 73 I.T., thence on a bearing of S 00°01'59"E a distance of 146.74' to the Point of Beginning;

Thence continuing along the east line of said Lot 73 I.T. on an assumed bearing of S 00°01'59" E a distance of 43.50'; Thence on a bearing of S 89°58'01"W a distance of 37.44 feet; Thence on a bearing of N 00°01'59" W a distance of 43.50'; Thence bearing N 89°58'01" E a distance of 37.44 to a point on the east line of said Lot 73 IT and the point of beginning and containing 1,628.61 Square Feet.

TO HAVE AND TO HOLD UNTO THE CITY OF LINCOLN, NEBRASKA, its successors and assigns, so long as such **Storm Sewer** shall be maintained, together with the right of ingress and egress to said property from the public streets, for the purpose of constructing, reconstructing, inspecting, repairing, maintaining, operating and replacing said **Storm Sewer** and appurtenances thereto, located thereon, in whole or in part, at the will of Grantee, it being the intention of the parties hereto that Grantor is hereby granting the uses herein specified without divesting Grantor of title and ownership of the rights to use and enjoy the above described property for any purpose except the construction thereon of permanent buildings, subject only to the right of the Grantee to use the same for purposes herein expressed, and subject to any prior leases or easements of record heretofore granted to other parties.

THIS INSTRUMENT, and the covenants and agreements herein contained, shall inure to the benefit of and be binding and obligatory upon the heirs, executors, administrators, successors and assigns of the respective parties.
