cation system consisting of one or more underground cables and such
conduits, wires, manholes, drains and splicing boxes, and such surface
testing terminals, repeaters and markers, and such other appurtenances,
as the grantees may from time to time require, upon, across, over and
under the land which the undersigned own or in which the undersigned have
any interest in Section 36, Township 9-N, Range 6-E,
County of Lancaster and State of Nebraska, known as Lot 61
remaining N-660 - E-792

including the following rights: Of ingress and egress over and across the
lands of the undersigned to and from said system for the purpose of exer-
cising the rights herein granted; to clear and keep cleared all trees,
roots, brush and other obstructions from the surface and subsurface within
eight feet of the system; to install gates in any fences crossing said
system; and to carry in said system the wires, circuits and appurtenances
of any other company. The undersigned for sel, heirs,
executors, administrators, successors and assigns, hereby covenant that
no structure shall be erected or permitted within eight feet of said system.
The grantees agree to pay for damage to fences and growing crops arising
from the construction and maintenance of the aforesaid system.

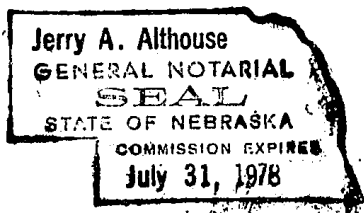
