THIS AGREEMENT, entered into this 27th day of November, 19 73, by and between NORTHERN NATURAL GAS COMPANY, a corporation, operating as PEOPLES NATURAL GAS Division, hereinafter called "Company", and Westward Development Company of Omaha Nebraska, hereinafter called "Applicant",

WITNESSTH THAT:

WHEREAS, Applicant is developing a tract of land known as: Skyline Estates, located in the Southwest Quarter of Section 24, all in Township 15 North, Range 10 East of the 6th PM in Douglas County, Nb., as shown on the plat attached hereto as Exhibit "A" and hereby made a part hereof, and desires natural gas service to such addition; and

NOW, THEREFORE, in consideration of the mutual promises and covenants herein contained, Company and Applicant agree as follows:

1. That Company will, with all reasonable expedition, provide service as described above to the above-described addition.
2. Applicant shall pay to Company or its successor a connection fee of \$230 per metered residential unit, as such unit is connected to Company's system (or its successor's system) on all lots sold. The total number of lots in Skyline Estates to which this \$230 connection fee will apply, (see attached plat, Exhibit A) if and when such connections are made, is agreed to be Thirty-seven (37). Amounts paid to Company (or its successor) pursuant to this paragraph 2

are also understood and agreed to constitute non-refundable contributions in aid of construction. Such \$230 fee shall be paid before each such connection (meter set installation) is made by Company or its successor.

3. Applicant agrees this contribution in aid of construction is made without right of claim for repayment.

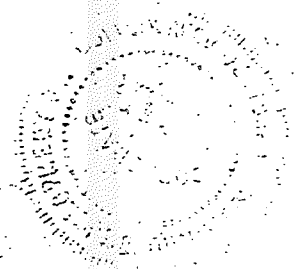

This Agreement shall inure to the benefit of and be binding upon the successors and assigns of both of the parties hereto; however, no assignment or other change in the identity of Applicant shall be effective insofar as Applicant's rights and obligations hereunder are concerned, without the prior written consent of Company, which consent shall not be unreasonably withheld.
