Said Protective Covenants run with the land, and are applicable to and binding upon the particular lots identified in each set of such Covenants, which said lots are located in the following-described subdivisions in Douglas County, Nebraska, to-wit:

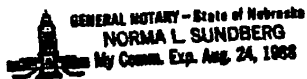
