AN ORDINANCE VACATING EXCESS RIGHT-OF-WAY ON 13TH AVENUE,
REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT
HEREWITH AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN FULL
FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY
OF BLAIR, NEBRASKA, AS FOLLOWS:

SECTION 1. Beginning at the northwest corner of Tax Lot 213 of Section 13, Township 18 North Range 11 East of the 6th P.M.; thence easterly along the north lot line of said Tax Lot 213 to a point 50 feet west of the southwest lot corner of Tax Lot 224 of said Section 13; thence northerly 50 feet along a line 50 feet west of and parallel to said Tax Lot 224; thence westerly along a line 50 feet south of and parallel to the south lot line of Tax Lot 223 of said Section 13 to a point on the east lot line of Tax Lot 79 of said Section 13, this point also being 50 feet south of the southwest lot corner of Tax Lot 223 of said Section 13; thence southerly along the west lot line of said Tax Lot 79 to the northwest lot corner of said Tax Lot 213 and the point of beginning is hereby vacated and the ownership of the same, pursuant to Neb. Rev. Stat. §16-611, providing, however, the City of Blair, for itself or its assignees, hereby reserves a perpetual easement for any public or private utilities located in said street, including but not limited to water lines, sewer lines, telephone, gas or cable television lines.

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect from and following the passage and publication hereof as required by law.
