WHEREAS, that three dedication plats establishing the street dedicated to public use recorded as follows:

Dedication Plat dated September 11, 1979, recorded October 30, 1979 in Plat Book 2, Pages, 287-288,

Dedication Plat dated June 19, 1981, recorded July 31, 1981 in Plat Book 2, Pages 315-316 and,

Dedication Plat dated December 23, 1983 recorded January 11, 1984 in Record Book 144, Pages 140-141.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BLAIR, NEBRASKA, that the street dedicated in aforementioned plats is to be known as 13th Avenue.

BE IT FURTHER RESOLVED THAT THE CITY CLERK OF THE CITY OF BLAIR, NEBRASKA, is hereby authorized to file this Resolution clarifying the name of this dedication with the County Clerk on behalf of the City of Blair, Nebraska.
