RELEASE OF LANDSCAPE EASEMENT

This Release of Easement is executed this 8th day of March, 2006

RECITALS:

1. Sanitary and Improvement District No. 218, was the beneficiary of a landscape easement on Lot 3, Southport East, a subdivision in Sarpy County, Nebraska as dedicated on the plat recorded as instrument 2001-30162 (the "Plat") in the Sarpy County Register of Deeds office.

2. The City of LaVista, Nebraska (the "City") annexed the property located within Southport East, and is now the beneficiary of the dedicated landscape easement.

3. Lot 3 and Lot 4 of Southport East have been replatted as Lots 1, 2 and 3, Southport East Replat Three, a subdivision in Sarpy County, Nebraska and recorded as Instrument No. 2006-04149 ("Replat 3"). The current property owner is Port Starboard, L.L.C. (the "Owner").

4. The City and the Owner desire the release the original landscape easement dedicated in the Plat.

5. A 50' landscape easement was created in Southport East Replat Three to replace the original landscape easement created in the Plat. Said replacement 50' landscape easement shall continue in full force and effect.

NOW THEREFORE, the City and the Owner, each on behalf of itself, its successors and assigns, hereby fully and irrevocably releases and terminates the landscape easement dedicated on instrument number 2001-30162, as of the date first written above.

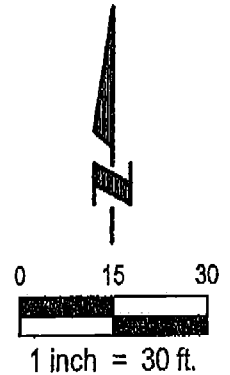
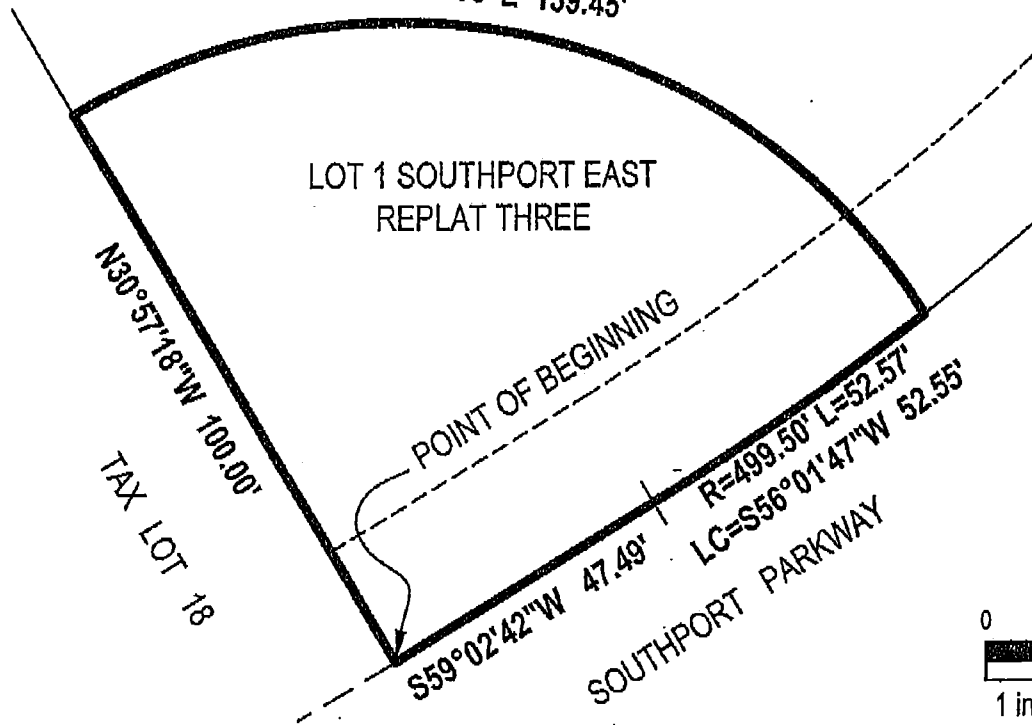

LEGAL DESCRIPTION

A PERMANENT LANDSCAPE EASEMENT GRANTED TO THE CITY OF LA VISTA, TO BE RELEASED, LOCATED IN LOT 1, SOUTHPORT EAST REPLAT THREE, A SUBDIVISION LOCATED IN THE SE 1/4 OF SECTION 18, TOWNSHIP 14 NORTH, RANGE 12 EAST OF THE 6TH P.M., SARPY COUNTY, NEBRASKA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF SAID LOT 1, SOUTHPORT EAST REPLAT THREE, SAID POINT ALSO BEING THE SOUTHEAST CORNER OF TAX LOT 18, A TAX LOT LOCATED IN SAID SE1/4 OF SECTION 18; THENCE N30°57'18"W (ASSUMED BEARING) ALONG THE WESTERLY LINE OF SAID LOT 1, SOUTHPORT EAST REPLAT THREE, SAID LINE ALSO BEING THE EASTERLY LINE OF SAID TAX LOT 18, A DISTANCE OF 100.00 FEET; THENCE SOUTHEASTERLY ON A CURVE TO THE RIGHT WITH A RADIUS OF 100.00 FEET, A DISTANCE OF 154.32 FEET, SAID CURVE HAVING A LONG CHORD WHICH BEARS S76°44'50"E, A DISTANCE OF 139.45 FEET TO A POINT ON THE EASTERLY LINE OF SAID LOT 1, SOUTHPORT EAST REPLAT THREE, SAID LINE ALSO BEING THE WESTERLY RIGHT-OF-WAY LINE OF SOUTHPORT PARKWAY; THENCE SOUTHWESTERLY ALONG SAID EASTERLY LINE OF LOT 1, SOUTHPORT EAST REPLAT THREE, SAID LINE ALSO BEING SAID WESTERLY RIGHT-OF-WAY LINE OF SOUTHPORT PARKWAY ON A CURVE TO THE RIGHT, WITH A RADIUS OF 499.50 FEET, A DISTANCE OF 52.57 FEET, SAID CURVE HAVING A LONG CHORD WHICH BEARS S56°01'47" W, A DISTANCE OF 52.55 FEET; THENCE S59°02'42"W ALONG SAID EASTERLY LINE OF LOT 1, SOUTHPORT EAST REPLAT THREE, SAID LINE ALSO BEING SAID WESTERLY RIGHT-OF-WAY LINE OF SOUTHPORT PARKWAY, A DISTANCE OF 47.49 FEET TO THE POINT OF BEGINNING.
