## SPECIAL PERMIT NO. 1870

8		4.	All privately-owned improvements, including landscaping, must be
9		permanently maintained by the Permittee, their successors and assigns.	
10		5.	The site plan approved by this permit shall be the basis for all
11	interpretations of setbacks, yards, locations of buildings, location of parking and circulation		
12	elements, and similar matters.		
13		6.	The terms, conditions, and requirements of this resolution shall be
14	binding and obligatory upon the Permittee, their successors, and assigns. The building		
15	official shall report violations to the City Council which may revoke the special permit or		
16	take such other action as may be necessary to gain compliance.		
17		7.	The Permittee shall sign and return the City's letter of acceptance to
18		the City Clerk within	n 30 days following approval of the special permit, provided, however,
19		said 30-day period	may be extended up to six months by administrative amendment. The
20	City Clerk shall file a copy of the resolution approving the special permit and the letter of		
21	acceptance with the Register of Deeds, filing fees therefor to be paid in advance by the		
22		Permittee.
