CORRECTIVE COVENANT NOTICE
(Stone Bridge Creek Fifth Addition)

The Restrictive Covenants for Stone Bridge Creek Fifth Addition were filed by the undersigned Owner and Developer on January 13, 2005 as Instrument No. 05-002587 on the following-described real estate:

Lots 1-16, Block One, Lots 1-18, Block Two, Lots 1-13, Block Four Stone Bridge Creek Fifth Addition, Lincoln, Lancaster County, Nebraska ("Single Family Properties");

Lots 17-22, Block 1, Lots 1-46, Block Three Stone Bridge Creek Fifth Addition, Lincoln, Lancaster County, Nebraska ("Townhome Properties");

and were collectively referred to as the "Fifth Addition Properties."

The **Existing Covenants** paragraph in the recorded instrument identified above contained an incorrect reference to one of the identified Restrictive Covenants. The correct information is set forth in the following restated paragraph:

Existing Covenants

Restrictive Covenants have been established, which were recorded with the Register of Deeds of Lancaster County, Nebraska on August 15, 2002, as Instrument No. 02-054310 and amended by the First Amendment to Restrictive Covenants filed in duplicate on October 1, 2002 as Instrument No. 2002-066401 and November 1, 2002 as Instrument No. 2002-076776 covering Stone Bridge Creek. Covenants for the First, Second, and Third Additions of Stone Bridge Creek were recorded on May 26, 2004 as Instrument No. 2004-034493. The Original, First Amendment First, Second, and Third Additions are referred to in this document collectively as "Covenants."

The Stone Bridge Creek Fifth Addition Restrictive Covenants are hereby ratified and confirmed.
