## **TEMPORARY CONSTRUCTION EASEMENT**



Marion Alyce Brewer, Trustee of The Marion Magee Brewer Trust, ("Grantor"), for valuable consideration, the receipt of which is hereby acknowledged, does hereby grant and convey to SANITARY AND IMPROVEMENT DISTRICT NO. 563 OF DOUGLAS COUNTY, NEBRASKA, and its successors and assigns ("Grantee"), a Temporary Construction Easement ("Easement") for the right to survey, grade, shape, excavate, inspect, construct and operate equipment for the installation of a public street and appurtenances thereto (collectively, the "Construction") over, under, and through the portions of the parcels of land legally described on Exhibit "A", inclusive, attached and incorporated herein (the "Easement Area").

TO HAVE AND TO HOLD, the Grantor and Grantee agree as follows:

- 1. The Grantor shall convey the Easement over, under and through the Easement Area to Grantee, for the purpose of the Construction.
- 2. This Easement shall commence on the date hereof and shall continue during the period of the Construction by the Grantee, and shall terminate 60 days after the completion of the Construction.
- 3. The Grantee, its engineers, contractors and agents, shall have the full right and authority of ingress and egress at all times upon the Easement Area in order to perform any of the acts and functions described within the purposes and scope of this Easement. Grantee and its engineers, contractors, and agents shall refrain from parking on the Grantor's driveway at any time.
- 4. After completion of the Construction, Grantee shall restore the surface of the Easement Area, meaning landscaping, decorative fencing, crops, grass, shrubbery and driveway, to Grantor's satisfaction to the condition existing prior to such work, reasonable wear and tear excepted.
- 5. It is further agreed that the Grantor has lawful possession of said real estate, and good right and lawful authority to make the conveyance herein subject to matters of record, and that the Grantor and its heirs, executors, administrators, successors and assigns shall warrant and defend the same.


