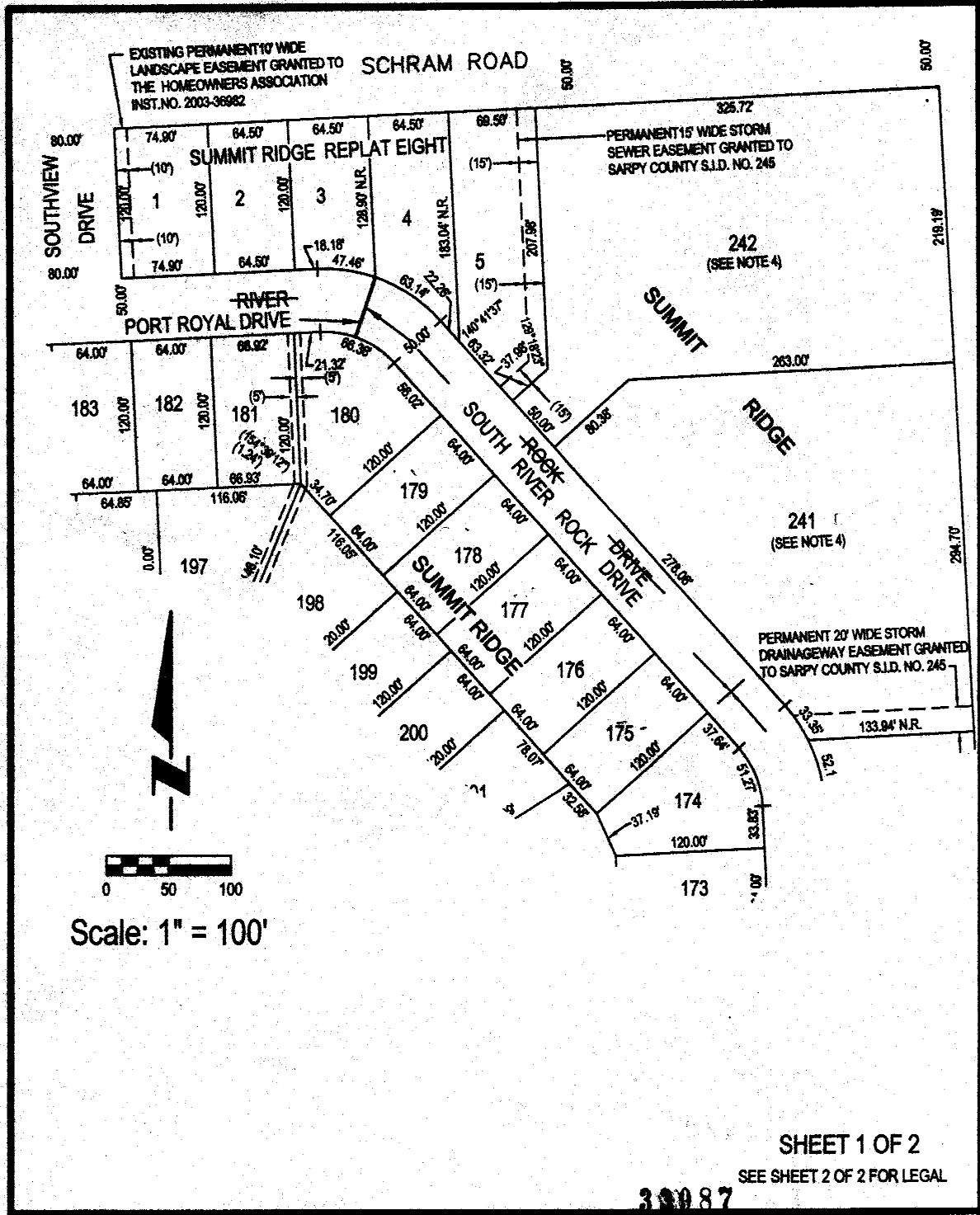

The street name affecting Lots 4 and 5, Summit Ridge Replat Eight to read South River Rock Drive instead of River Rock Drive.

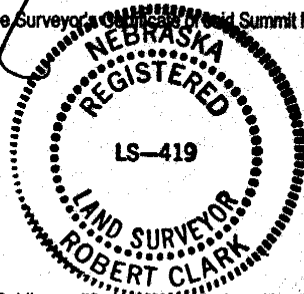

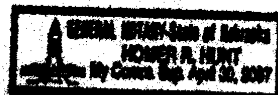
