

LEGAL DESCRIPTION

A TRACT OF LAND LYING IN THE NORTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 12, TOWNSHIP 18 NORTH, RANGE 11 EAST OF THE 6TH P.M. IN WASHINGTON COUNTY, NEBRASKA, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT 648.0 FEET EAST AND 33.0 FEET SOUTH OF THE NORTHWEST CORNER OF SECTION 12, TOWNSHIP 18 NORTH, RANGE 11 EAST, SAID POINT BEING ON THE SOUTHERLY R.O.W. OF ADAMS STREET, AND ASSUMING THE WEST LINE OF LOTS 4 AND 12, BLOCK 118, ELEVENTH ADDITION TO BE DUE NORTH AND SOUTH; THENCE SOUTH A DISTANCE OF 884.09 FEET; THENCE SOUTH 10° 02' EAST A DISTANCE OF 114.75 FEET; THENCE SOUTH A DISTANCE OF 187.0 FEET TO THE NORTHERLY R.O.W. OF JACKSON STREET; THENCE EAST ALONG SAID R.O.W. A DISTANCE OF 38.0 FEET; THENCE NORTH A DISTANCE OF 187.0 FEET; THENCE NORTH 4° 3' WEST A DISTANCE OF 113.28 FEET; THENCE NORTH A DISTANCE OF 883.94 FEET TO THE SOUTHERLY R.O.W. OF ADAMS STREET; THENCE WESTERLY 50.0 FEET TO THE POINT OF BEGINNING, LYING IN LOTS 3, 4, 11, AND 12, BLOCK 118, ELEVENTH ADDITION TO THE CITY OF BLAIR, WASHINGTON COUNTY, NEBRASKA.
