AMENDED DECLARATION

OF

COVENANTS, CONDITIONS AND RESTRICTIONS

THIS AMENDED DECLARATION made in the year 1996, by the undersigned and shall become effective on its date of recording in the Office of the Register of Deeds of Lancaster County.

WHEREAS, Tabitha New Community Home Owners Association, a Nebraska not for profit corporation, also known as Autumn Wood Home Owners Association, hereinafter referred to as the "Association", is the Owner of certain real property in the City of Lincoln, County of Lancaster, Nebraska, known as the Common Area and also referred to as "The Commons", which is more particularly described as:

For Legal Description, See Exhibit "1", attached hereto.

and,

WHEREAS, the undersigned are the Owners of the certain real property in the City of Lincoln, in the County of Lancaster, Nebraska, known as the "Properties", following the respective names, and such Owners are the owners of two-thirds (2/3) of the "Lots", "Living Units", and "Condominium Units" located within the "Properties" which are more particularly described as:

For Legal Description, See Exhibit "2", attached hereto.

NOW THEREFORE, the undersigned, the Association and Owners, hereby release the Restrictive Covenants dated March 4, 1986, and recorded March 4, 1986, as Instrument No 86-5464, the Amendments to Covenants dated February 15, 1991, and recorded February 15, 1991, as Instrument No. 91-4338, the Amendments to Covenants dated February 15, 1991, and recorded February 15, 1991, as Instrument No. 91-4339; and Amendments to Covenants dated September 9, 1992, but never recorded at the Register of Deeds Office; all of which, except the Amendment (102196)

dated September 9, 1992, were recorded in the Office of the Register of Deeds of Lancaster County, Nebraska; and,

WHEREAS, the Tabitha New Community Home Owners Association has been incorporated in Nebraska as a not for profit corporation for the purposes of enforcing the covenants, conditions and restrictions that may be adopted and amended from time to time, established upon the "Properties" and "The Commons" hereinbefore described.

NOW THEREFORE, the undersigned hereby declare that all of the "Properties" described above shall be held, sold and conveyed subject to the following easements, covenants, conditions, and restrictions, which are for the purpose of protecting the value and desirability of, and which shall run with the real property and be binding on all parties having any right, title or interest in the described "Properties" or any part thereof, their heirs, successors and assigns, and shall inure to the benefit of each owner thereof.

ARTICLE I

DEFINITIONS

Section 1. "Association" shall mean and refer to Tabitha New Community Home Owners
Association also known as Autumn Wood Home Owners Association, its successors and assigns.

Section 2. "Properties" shall mean and refer to that certain real estate and facilities described in this Declaration of Covenants, Conditions and Restrictions, and such additions thereto as my hereafter be brought within the jurisdiction of the Association.

Section 3. "The Commons" shall mean all real property owned by the Association described in the Declaration of Covenants, Conditions and Restrictions, and such additions thereto as may hereafter be brought within the jurisdiction of the Association for the common use and enjoyment of the Owners. The Commons may also be referred to as the "Common Area" in this Declaration, the Articles of Incorporation and ByLaws of the Association.

Section 4. "Lot" shall mean and refer to any plot of land that is subject by the covenants of record to assessment by the Association and that is shown upon any recorded subdivision map of the Properties with the exception of The Commons. It shall, by extension, include any living

unit that is related to the aforementioned plot of land and that is subject to assessment by the Association.

Section 5. "Owner" shall mean and refer to the record owner, whether one or more personal or entities, of the fee simple title to any Lot, Living Unit, or Condominium Unit which is part of the Properties, including contract sellers, but excluding those having such interest merely as security for the performance of an obligation.

Section 6. "Articles" shall mean and refer to the Articles of Incorporation of Tabitha New Community Home Owners Association, a Nebraska not for profit corporation, filed with the Secretary of State's Office.

Section 7. "Covenants" shall mean and refer to this Amended Declaration of Covenants, Conditions, and Restrictions applicable to the Properties and The Commons to be recorded in the Office of the Register of Deeds of Lancaster County, Nebraska, and any amendments thereto as may hereafter be recorded in such Office of the Register of Deeds.

Section 8. "Member" shall mean and refer to those persons entitled to voting rights in the Association.

Section 9. "Assessment" shall mean and refer to any Association dues that are payable the first of each month, which are past due after thirty (30) days.

Section 10. "Living Unit" shall mean and refer to any abode of a householder — whether apartment, single dwelling, condominium, or other — that shall house a Member or Member couple on a Lot subject to these Covenants. Whenever the term "condominium" or "condominium unit" is used in these covenants it shall be synonymous with the term "living unit".

Section 11. "Proxy" shall mean and refer to a written vote accompanied with a durable power of attorney granting the person voting such power.

ARTICLE II

EASEMENTS, COVENANTS, CONDITIONS AND RESTRICTIONS

Section 1. "Use Restrictions":

A. No Lot within the Properties shall be used other than for residential purposes.

- B. Ownership and occupancy of each Living Unit is hereby restricted to parties of the age of 55 years and older provided, however, that one of two or more joint owners may be under the age of 55 provided that the said Owner or Owners under the age of 55 sign an affidavit acknowledging their understanding that they may not reside in the Living Unit nor use any of the improvements or common elements until those parties signing the affidavit reach the age of 55.
- C. A party under the age of 55 may own and/or reside in a Living Unit and make use of any and all improvements or common elements in the event that his or her spouse is of the age of 55 or more and is also an Owner or resident of the same unit, and such party, under the age of 55, may continue such ownership or residence of the same unit after the demise of that spouse of age 55 or older.
- D. A party under the age of 55, but over the age of 16 may reside in a Living Unit and make use of any and all improvements or common elements in the event that that individual, provided no more than two such individuals in any one Living Unit, is related to another permitted occupant of that Living Unit by consanguinity.
- E. This Section is effective in accordance with the Federal Fair Housing Amendments Act of 1988, and particularly Paragraph 100.304, as the same then existed, or may have thereinafter been amended, or hereinafter be amended, however, shall have no affect upon those parties who were owning a unit or residing in any unit on February 15, 1991, and shall be perspective in enforcement only.
- F. This Section is to be interpreted in such a way as to comply with all Federal and State laws and regulations relating to such matters.

Section 2. "Completion of Construction". Any building placed or constructed upon any lot within the Properties shall be completed within six months after the commencement of construction.

Section 3. "Approval of Plans". Plans for any improvement to be placed or constructed upon any Lot within the Properties shall be submitted to the Association and shall show the design, size and exterior material for the improvement and the plot plan for the Lot. One set of plans shall be left on permanent file with the Association. Construction of the improvement shall not be

commenced unless written approval of the plans has been secured from the Association. Written approval or disapproval of the plans shall be given by the Association within 30 days after receipt. Approval of the plans shall not be unreasonably withheld, and upon disapproval, a written statement of the grounds for disapproval shall be provided. The Association shall have the exclusive right to disapprove the plans, if in the Associations' opinion the plans do not conform to the general standard of development within the Properties. The Lots located within Blocks 6, 10, and 11, Tabitha New Community Addition, Lincoln, Lancaster County, Nebraska, are not subject to the provisions of this Section.

Section 4. "Temporary Structures". No partially completed dwelling or temporary building and no trailer, tent, shack or garage on any Lot within the Properties shall be used as either a temporary or permanent residence.

Section 5. "Nuisance". No noxious or offensive activity shall be conducted or permitted upon any Lot within the Properties, nor anything which is or may become an annoyance or nuisance to the neighborhood or which endangers the health or unreasonably disturbs the quiet of the occupants of adjoining Lots.

Section 6. "Signs". No advertising signs, billboards, or other advertising devices shall be permitted on any Lot within the Properties. However, the Owners may erect signs advertising Lots or Living Units for sale within the Properties, and a sign advertising a single Lot or Living Unit for sale may be erected upon any Lot.

Section 7. "Animals". No animals, livestock, or poultry of any kind shall be raised, bred or kept on any Lot within the Properties for any commercial purpose.

Section 8. "Party Walls". Any wall constructed on any common Lot line between two adjoining Lots within the Properties shall be a party wall. Any expense of structural repair, replacement or reconstruction of a party wall, or of the protection of a party wall against the natural elements, shall be borne equally by the members who are the title holders of the adjoining Lots. The provisions of this paragraph shall not operate to relieve any member from any liability which the Member may incur by reason of negligent or willful acts or omissions resulting in damage to a party wall.

Section 9. "Fences". No fences shall be installed on the Commons or the Properties, provided however, nothing contained herein shall prohibit the right of any Owner to install an enclosure fence no more than 24 inches in height around a flower or vegetable garden on the owner's lot within the Properties.

Section 10. "Common Utility Lines". When any utility line shall be constructed on two or more adjoining Lots within the Properties, each Member who is the titleholder of one of the adjoining Lots shall have an easement for the maintenance, repair and replacement of the utility line upon all of the adjoining Lots, which easement shall be appurtenant to the interest requisite for membership. Any expense of maintenance, repair or replacement of the utility line shall be borne equally by the members who are the title holders of such adjoining Lots. The provisions of this paragraph shall not operate to relieve any member from any liability which such member may incur by reason of negligent or willful acts or omissions resulting in damage to the utility line.

Section 11, "Homeowners Association". Every person or entity who becomes a titleholder of a fee simple or undivided fee simple interest in any Living Unit or Lot within the Properties, including a condominium or apartment unit, shall be a Member of the Association. However, any person or entity who holds such interest merely as security for the performance of any obligation shall not be a Member. Only one vote may be cast for each Living Unit, or Lot, as the case may be, and the Owner of a Living Unit or Lot may authorize the occupant to cast such vote by durable power of attorney. When there is more than one Living Unit on a Lot, the Owner of each Living Unit shall have one vote per unit and the Lot itself shall have no vote as a Lot. Any vote upon any matter covered by any Section of this Amended Declaration requiring a vote of the members shall be held at an annual or special meeting of the Association after due notice thereof, as required by the Articles of Incorporation of the Association. A quorum at such meeting shall be one tenth (1/10) of the votes of the entire Association entitled to vote, present in person or by absentee ballot or durable power of attorney or by proxy. All absentee ballot requests shall be in writing, signed by the voter and filed with management. All absentee ballot requests must qualify under Lancaster County Election Office voting criteria. All absentee ballots shall be treated as secret ballots. A proxy to vote will only be accepted as a vote if accompanied \(^{\infty}\) with a durable power of attorney granting the person voting such power.

Section 12. "Use of Commons". Each Member of the Association shall have the right to use and enjoy The Commons and shall have an easement upon The Commons for the use thereof, which shall be appurtenant to the interest requisite for membership.

Section 13. "Rights in The Commons". The rights and easements of the Members of the Association shall be subject to:

- A. The right of the Association to borrow money for the purpose of improving The Commons and to mortgage, pledge, deed in trust, or hypothecate any or all of real or personal property located within The Commons owned by The Association as security for money borrowed or debts incurred. In the event of default, the mortgagee shall have the right, after taking possession of The Commons, to charge admission and other fees as a condition of the continued use of any recreations facilities within The Commons by the Members, and to open the facilities to a wider public until such debt is satisfied. Any mortgage or such encumbering of The Commons shall be approved by the affirmative vote of two-thirds (%) of the Members voting, present in person or by absentee ballot or durable power of attorney, at a regular meeting of the Members or at a special meeting of the Members, if notice of the proposed mortgage or encumbering is contained in the notice of the regular meeting or the special meeting.
- B. The right of the Association to take any steps reasonably necessary to protect The Commons against foreclosure.
- C. The right of the Association to suspend the enjoyment of the facilities by any Member for any period during which an assessment remains unpaid, and for a period not to exceed 30 days for any infraction of the published rules and regulations governing the use of the facilities.
- D. The right of the Association to charge reasonable admission and other fees for the use of the facilities.
- E. The right of the Association to dedicate or convey all or any part of The commons to any public entity or to the Owner of any Lot or Living Unit within the Properties. Any dedication or conveyance shall be approved by the affirmative

vote of two-thirds (%) of the Members voting present in person or by absentee ballot or durable power of attorney, at a regular meeting of the Member or at a special meeting of the Members, if notice of the proposed dedication or conveyance is contained in the notice of the special meeting.

Section 14. "Maintenance of The Commons". The Association covenants and each Member of the Association, by the acceptance of a deed by which the interest requisite for membership is acquired, shall be deemed to covenant to maintain The Commons, which covenants by the Members shall be satisfied by the payment of annual and special assessments for the administration, maintenance or improvement of The Commons. Annual and special assessments shall be uniform and to each Living Unit within the Properties. Each assessment shall be the personal obligation of the Member who is, or was, the titleholder of the Living Unit assessed at the time of the assessment, shall bear interest at the rate of ten percent (10%) per annum until paid and, when shown of record, shall be a lien upon the Living Unit assessed.

Section 15. "Use of Common Driveways". Each Member of the Association, who is a titleholder of a Living Unit which has access to a street by way of a common driveway, shall have an easement upon such common driveway for ingress and egress from and to the street, which shall be appurtenant to the interest requisite for membership.

Section 16. "Maintenance of Common Driveways". The Association covenants to maintain each common driveway serving two or more Living Units. Each Member of the Association, who is the titleholder of a Living Unit which has access to a street by way of a common driveway, shall be deemed to covenant to maintain the common driveway. The covenants by such Members may be satisfied by the payment of annual and special assessments for the maintenance of common driveways. Each assessment shall be the personal obligation of the Member who is, or was, the titleholder of the Living Unit assessed at the time of the assessment, shall bear interest at the rate of ten percent (10%) per annum until paid and, when shown of record, shall be a lien upon the Living Unit assessed.

Section 17. "Maintenance of Exteriors". The Association may maintain any Lot and the exterior of any improvements within the Properties, excluding glass surfaces, and shall have the right to enter upon any Lot within the Properties, at reasonable times, to perform maintenance.

The cost of the maintenance shall be specially assessed. Each assessment shall be the personal obligation of the Member who is, or was, the titleholder of the Living Unit assessed at the time of the Assessment, shall bear interest at the rate of 10 percent (10%) per annum until paid and, when shown of record, shall be a lien upon the Living Unit assessed.

Section 18, "Insurance". Each Member of the Association shall be deemed to covenant to maintain fire and extended coverage insurance on improvements in an amount equal to the full insurable value thereof. Any proceeds of insurance shall be applied, to the extent required by the Association, to the repair or reconstruction of the improvements. The Association may maintain such insurance and add the cost thereof to the next annual assessment.

Section 12. "Lien of Assessments". The lien of any annual or special assessment shall be subordinate to the lien of any mortgage or deed of trust placed upon the Lot or Living Unit against which the assessment is levied.

Section 20. "Annual and Special Assessments". Annual and special assessments, other than for capital improvements, may be levied by the Board of Directors of the Association. The total of all assessments for any year shall not exceed the prior year by more than 10% unless approved in the same manner as a special assessment for capital improvements. Any special assessment for capital improvements shall be approved by the affirmative vote of two-thirds (%) of the Members voting, present in person or by absentee ballot or durable power of attorney, at a regular meeting of the Members or at a special meeting of the Members, if notice of a special assessment is contained in the notice of the special meeting.

Section 21. "Additions". Tabitha New Community Home Owners Association may add additional contiguous or adjacent real estate to the Properties or The Commons, at any time, with the approval of the members of the Association. Any addition shall be approved in the same manner as a special assessment for capital improvements. Additions shall be made by the execution and recordation of a Declaration upon the additional real estate, making the addition subject to this Declaration of Covenants, Conditions, and Restrictions.

Section 22. "Amendments". This Declaration of Covenants, Conditions and Restrictions shall run with the land and shall be binding upon and enforceable by the Owners and all persons claiming under the Owners. This Declaration may be terminated or modified, in writing, and

signed by the Owners of two-thirds (2/3) of the Lots, Living Units and Condominiums Units within the properties at any time.

Section 23, "Enforcement". The enforcement of this Declaration may be by proceedings at law or in equity against any person violating or attempting to violate any provision hereof. The proceedings may be to restrain the violation, or to recover damages and, by the Association, may be to enforce any lien or obligation created hereby.

Section 24. "Severability". The invalidation of any one of the provisions of this Declaration shall not affect the validity of the remaining provisions hereof.

Section 25. "Priority". Should any conflict or ambiguity among the Declaration of Covenants, as amended from time to time, the Articles of Incorporation of the Association and the Bylaws of the Association arise or be discovered the Declaration of Covenants shall be controlling; and should any conflict or ambiguity arise or be discovered between such Articles and the Bylaws, the Articles shall be controlling.


