- 1. The undersigned are residents of Lincoln, Lancaster County, Nebraska, and are the duly qualified and acting President and Secretary of Tabitha New Community Home Owners Association, a Nebraska nonprofit corporation (the "Association").
- 2. Amended Declaration of Covenants, Conditions and Restrictions (the "Amended Declaration") was recorded on July 29, 1997, as Instrument No. 97-30082, with the Lancaster County Register of Deeds, bearing the signatures of individuals and entities purporting to be the record owners of approximately 182 lots and living units of the lots and properties described on Exhibit A attached hereto and incorporated herein by this reference. Based on this instrument, the Board of Directors of the Association determined that the Amended Declaration was validly adopted.
- 3. Upon further review and analysis of the identity of fee title holders of such real estate, the Association has concluded that the Amended Declaration does not bear a sufficient number of signatures of the owners of lots and living units to constitute adoption of the same. Therefore, the Board of Directors of the Association has concluded that the Amended Declaration is of no force or effect, and that all covenants previously in effect were not revoked notwithstanding any language to the contrary in the Amended Declaration, and such prior covenants and instruments are in full force and effect.
