In consideration of mutual benefits to be derived from the facilities proposed hereinafter, and the further consideration of One and 00/100 Dollars (\$1.00) in hand paid, receipt whereof is hereby acknowledged, the undersigned, owner of Tabitha Community

in the City of Lincoln, Lancaster County, Nebraska, do hereby grant and convey to THE LINCOLN TELEPHONE AND TELEGRAPH COMPANY and to their successors and assigns, and to the LINCOLN ELECTRIC SYSTEM, its successors and assigns, and to T-V TRANSMISSION INC., a Nebraska Corporation, and to its successors and assigns, the right to construct, reconstruct, perpetually maintain, and operate underground electric power telephone and television lines, together with the necessary cables, wires, underground conduits, aboveground appurtenances, etc., with the right to enter said premises for the purpose of installing, repairing, replacing, operating, and maintaining and removing said joint electric power, telephone and television lines in, over and under the said property at about the following location:

Section 1, Township-10-North, Range-6-East; a strip of land 10 feet wide along and parallel to the southerly right-of-way of Folksway Boulevard as it now exists and as it is extended in the future

This grant shall be binding upon the heirs, executors, administrators, successors, and assigns of the grantors herein.
