DECLARATION OF ANNEXATION
AND ASSENT

COMES NOW Tabitha Development Corporation, by _____
Frederick C. Nolte, its President, and says:

WHEREAS, Tabitha Development Corporation, on May 30, 1975, executed a Declaration of Covenants, Conditions and Restrictions (hereinafter referred to as DECLARATION) and recorded same in the office of the Register of Deeds, Lancaster County, Nebraska, Instrument No. 75-8420.

WHEREAS, said DECLARATION has from time to time been duly amended in accordance with law and said amendments (hereinafter referred to as AMENDMENTS) have been recorded in the office of the Register of Deeds, Lancaster County, Nebraska, Instrument Nos. 77-1978, 77-1979, 77-1980, 77-5532, 77-5533;

WHEREAS, Tabitha Development Corporation is the Declarant in said DECLARATION and AMENDMENTS;

WHEREAS, the DECLARATION and AMENDMENTS impose Covenants, Conditions and Restrictions upon certain property in Lincoln, Lancaster County, Nebraska, which is more particularly described as:

All of Tabitha New Community Addition
including all of Blocks 5 and 7 of Replat
of Blocks 5 and 7, Lincoln, Lancaster
County, Nebraska, and

All of Tabitha New Community First Addition,
Lincoln, Lancaster County, Nebraska.

WHEREAS, Tabitha Development Corporation is the owner of certain real property abutting on portions of the above-described real estate, which abutting property is more particularly described as:

Tabitha New Community Second Addition to
Lincoln, Lancaster County, Nebraska.

WHEREAS, Tabitha Development Corporation is desirous of subjecting said abutting property to the terms of the DECLARATION and AMENDMENTS;

WHEREAS, under ARTICLE VI, Section 4, Paragraph (b) of the DECLARATION and AMENDMENTS, Declarant Tabitha Development Corporation is empowered for a period of ten (10) years from the date of the DECLARATION to annex additional land;

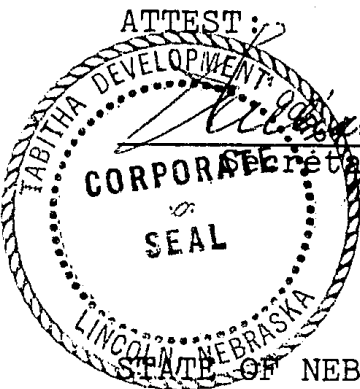

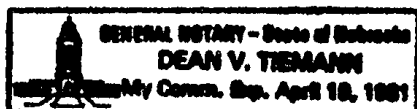
