## AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

WHEREAS, the undersigned are, according to Article III of the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS, (DECLARATION hereinafter), members of the Tabitha New Community Home Owners Association;

WHEREAS, the undersigned members comprise at least 90% of the total membershop of the Tabitha New Community Home Owners Association.

NOW THEREFORE, pursuant to Article VD, Section 3, of the DECLARATION, the same is hereby amended in the following respects:

Article VII, USE PROVISIONS, Section 1, Age Restriction, is amended by adding a new subsection which reads as follows:

(e) The provisions of the foregoing notwithstanding, the age restrictions shall not apply to inhabitants of Lot 1, Block 2, Tabitha New Community Second Addition, Lincoln, Lancaster County, Nebraska, if said inhabitants are eligible to occupy said premises as Elderly or Handicapped Families within the meaning of 12 U.S.C. Section 1701q and 24 C.F.R. Part 885, as the same now exist or may be hereinafter amended.


