AMENDMENT TO BY-LAWS OF TERRA COTTA CONDOMINIUMS

The By-Laws of Terra Cotta Condominiums are hereby amended as follows:

- Reinstate Article V, Section 9, sub-paragraph (o) of the original by-laws. This paragraph was previously removed by amendment on February 15, 1983. This sub-paragraph reads:
 - "No pets are allowed on the Common Elements or within any Unit without the permission of the Board of Administrators. In no event shall large animals be permitted in the Units or on the Common Elements."
- Add the following sentence to Article V, Section 9, sub-paragraph (h):
- "A building-wide content delivery system may be approved by the Board of Administrators."
 - Replace Article II, Section 4 with the following paragraph:
 - "It shall be the duty of the President to call a special meeting of the Association of Co-Owners if so directed per Nebraska state law 76-866, or its applicable successor law."

The By-laws of Terra Cotta Condominiums were previously recorded at Book 1700, Page 508, in the Records of the Douglas County Register of Deeds, and amended as recorded at Book 690, Page 701, in the Records of the Douglas County Register of Deeds.

The Master Deed encumbers Lots 6, 7, 8 and the north 21.53 feet of Lot 9, Block 1, Jerome Park Addition to the City of Omaha, Douglas County, Nebraska, now known as Units 1-4. Units 11-16, Units 21-26, and Units 31-36 of Terra Cotta Condominums.
