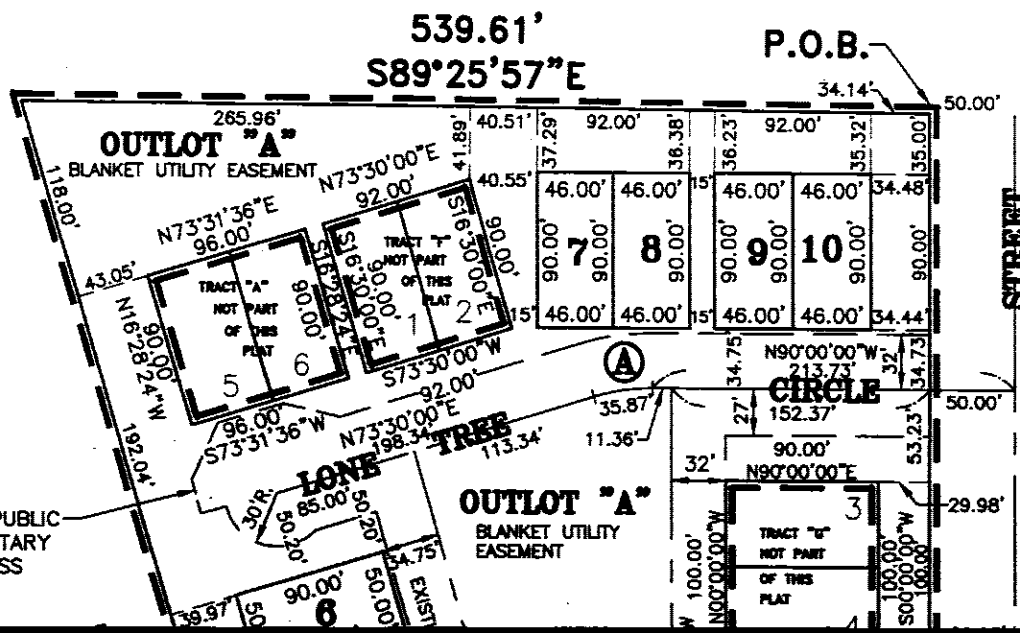


THE RIDGE 28TH ADDITION ADMINISTRATIVE FINAL PLAT
