All of the provisions of the Agreement and any subsequent amendments thereto, if any, even though not set forth herein, are by the filing of this Memorandum of Agreement for The Rows at Coventry, Lots 1 180 made a part hereof by reference. Anyone making any inquiry or claim regarding any of said Development Property in any manner whatsoever shall be fully advised

as to all of the terms and conditions of the Agreement, and any amendments thereto, as if the same were fully set forth herein.

- 3. A copy of the Agreement and any subsequent amendments thereto, if any, shall be maintained on file for public inspection during ordinary business hours in the office of the City Clerk, Omaha, Nebraska.
- 4. The topics, regulations, rights, and duties contained in the Agreement include, but are not limited to, the following:
 - a. The owners of Lots 1 180, The Rows at Coventry, shall be members of The Rows at Coventry Owners Association.
 - b. All permanent maintenance (including repair, upkeep, replacement, and snow removal) of the pavement in Outlot A, The Rows at Coventry, and in Outlots F through S (inclusive), The Rows at Coventry, shall be the responsibility of The Rows at Coventry Owners Association.
 - c. Some or all of the lots within the subdivision do not have frontage to public right-of-way and/or a public street. Such lots will be served by a paved access that will be privately maintained; no maintenance will be performed on this access by the City.


