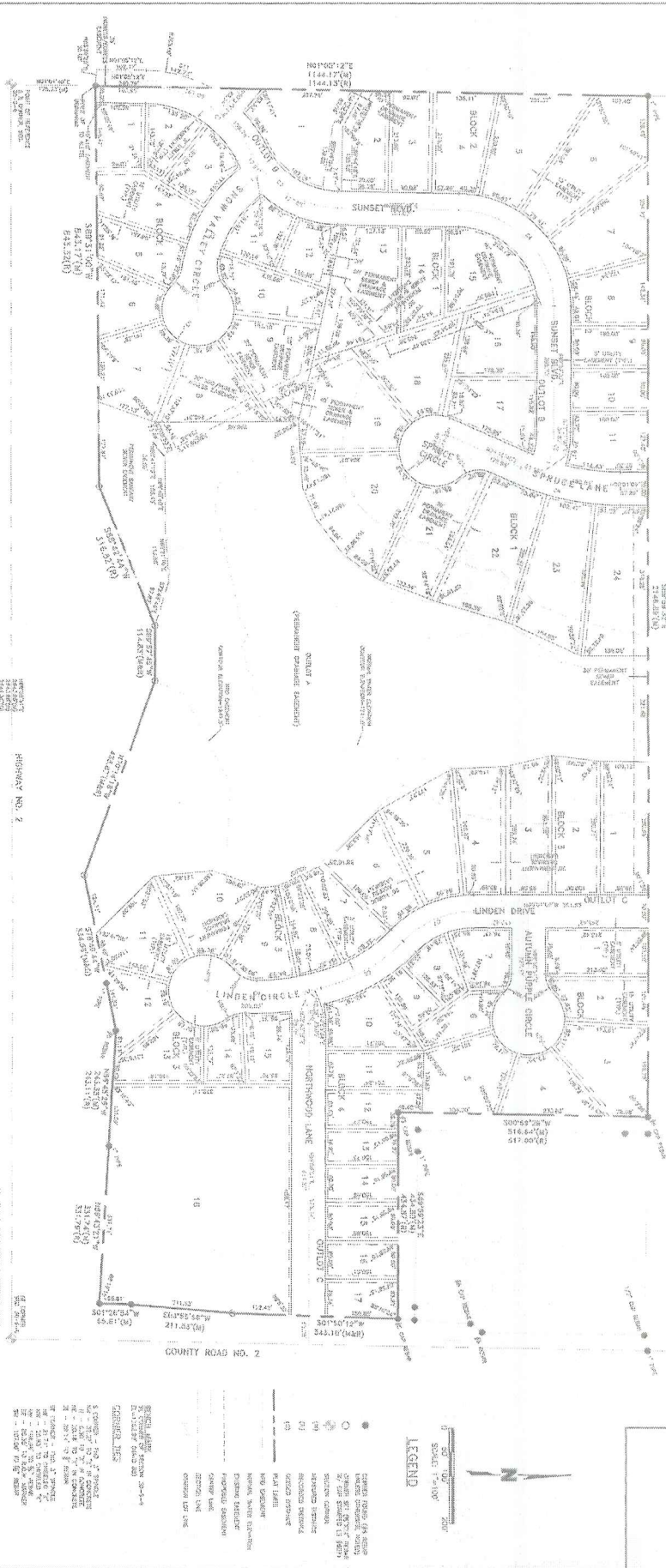


TIMBER LAKE FINAL PLAT
