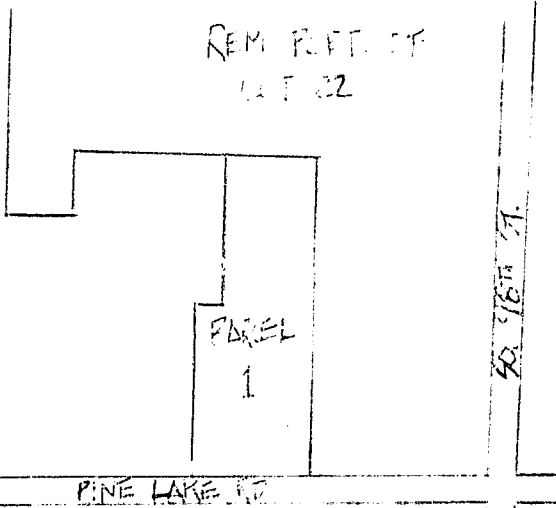

PARCEL 1

LEGAL DESCRIPTION:

Referring to the Southwest corner of the East One-Half of the Southeast Quarter of Section 14, Township 9 North, Range 7 East of the 6th P.M., Lancaster County, Nebraska. Thence in an Easterly direction along the South line of the said East One-Half of the Southeast Quarter a distance of Four Hundred Ninety-Two and No Tenths (492.0) feet to the Point of Beginning. Thence left in a Northerly direction parallel to the West line of the said East One-Half of the Southeast Quarter a distance of Four Hundred Eighty-Three and No Tenths (483.0) feet. Thence right parallel to the South line of the said East One-Half of the Southeast Quarter a distance of Seventy-Six and No Tenths (76.0) feet. Thence left in a Northerly direction parallel to the West line of the said East One-Half of the Southeast Quarter a distance of Three Hundred Eighty-One and Two Tenths (381.2) feet. Thence right in an Easterly direction parallel to the South line of the said East One-Half of the Southeast Quarter a distance of Two Hundred Twenty-Two and No Tenths (222.0) feet. Thence right in a Southerly direction parallel to the West line of the said East One-Half of the Southeast Quarter a distance of Eight Hundred Sixty-Four and Two Tenths (864.2) feet to a point on the South line of the said East One-Half of the Southeast Quarter.
