DEDICATION

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, being the owners of part of the East 1/2 of the Southwest 1/4 of Section 10, T.17N., R.8E., of the 6th PM described as follows: Commencing at the South 1/4 corner of Section 10, thence North along the north-south centerline of said section (538 feet), thence Northwesterly to a point on the west line of the east 1/2 of the Southwest 1/4 of said section 1238 feet north of the south line of said section, thence South along the west line of the east 1/2 of the Southwest 1/4 of said section to a point 703 feet north of the south line of said section, thence East and parallel to the south line of said section to a point 350 feet west of the east line of the Southwest 1/4 of said section, thence South and parallel to the east line of the Southwest 1/4 of said section 710 feet, thence East along the south line of said section 350 feet to the place of beginning.

We hereby subdivide and plat said tract as WASHINGTON HEIGHTS ADDITION to Fremont, Nebraska. Said addition consists of 9 blocks numbered 1, 2, 3, 4, 5, 6, 7, 8 and 9. Said blocks are subdivided into lots with their number and dimension shown on this plat. We dedicate for perpetual use by the public, COLORADO AVENUE, MISSOURI AVENUE, KANSAS AVENUE, DAKOTA STREET, and IOWA STREET, which are 50 feet in width, and the north one-half of 23 RD. STREET. We hereby grant to the City of Fremont, any public or private utility company and for reciprocal use by shutting property owners, an easement on the east 10 feet of block 1, the north 20 feet of all lots in blocks 6, 7, 8 & 9, and the rear 10 feet of all other lots in this addition.
