## PERMANENT EASEMENT

THIS INDENTURE, made this 5 day of October 1967, by and between CATHOLIC ARCHBISHOP OF OMAHA, INC., sometimes hereinafter referred to as "Owner", and SANITARY AND IMPROVEMENT DISTRICT NO. 91 OF DOUGLAS COUNTY, NEBRASKA, sometimes hereinafter referred to as "District".

## WITNESSETH:

That the Owner, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, to it in hand paid by District, the receipt of which is hereby acknowledged, does hereby grant, sell, convey and confirm unto said District and its assigns, perpetually and forever, the right to construct and maintain a sewer and drainage system over and under a parcel of land legally described as follows:

That part of the SW 1/4 of Section 20, T 15 N, R 12 E of the 6th P.M., Douglas County, Nebraska, described as follows: Beginning at a point 417.66 feet North of and 50.0 feet East of the Southwest corner of Section 20, said point being on the East R.O.W. line of 120th Street; thence South 21° 30' E, 58.18 feet; thence N 68° 30' E, 20.0 feet; thence N 21° 30' W, 108.96 feet to a point on the East R.O.W. line of 120th Street; thence South on the East R.O.W. line of 120th Street; thence 54.58 feet to the point of beginning (The West line of the SW 1/4 of Section 20 assumed North-South in direction) and

That part of the SW 1/4 of Section 20, T 15 N, R 12 E of the 6th P.M., Douglas County, Nebraska, described as follows: Beginning at a point 1447.16 feet North of and 50.0 feet West of the Southwest corner of said Section 20, said point being on the East R.O.W. line of 120th Street; thence N 47° 30' E, 98.94 feet; thence N 42° 30' W, 20.0 feet; thence S 47° 30' W, 85.42 feet to a point on the East R.O.W. line of 120th Street; thence South on the East R.O.W. line of 120th Street, 27.12 feet to the point of beginning. (The West line of the SW 1/4 of Section 20 assumed to be North-South in direction).

Said easement is granted upon the express condition that if any changes, repairs or alterations are necessary to be made at any time or if any portion of said sewer and drainage system need to be reconstructed, the District shall make good to the Owner of such land,

all damages that may be done by said changes, alterations, repairs or reconstruction, in the way of damage to trees, grounds, buildings or other improvements thereon, including crops, vines, gardens and lawns during construction and thereafter.

Said District agrees to pay all costs of construction of said sewer and drainage system and leave the premises in a neat and orderly condition.

The exact location of construction within the permanent easement conveyed herein shall be fixed by the engineer for the District.

Said Owner for itself and its successors in title does confirm with the said District and its assigns, that it, the said Owner, is well seized in fee of the premises aforesaid and that it has the right to grant and convey this permanent easement in the manner and form aforesaid, and that it will, and its assigns and successors in title shall warrant and defend this easement to said District and its assigns and successors against the lawful claims and demands of all persons.




