That said Grantor(s) in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, to Grantor(s) in hand paid by said City, the receipt whereof is hereby acknowledged, does or do hereby grant, sell, convey and confirm unto said City and its assigns forever, the right to use, construct, build, lay, maintain, repair and reconstruct a sanitary or storm sewer pipe or both for the passage of sewer water and sewage, together with all appurtenances, wires, lines, poles, structures, and other applicable equipment pertaining to any sewer, in, through, over and under the parcel of land described as follows, to-wit:

A permanent sewer and drainage easement in the Southwest 1/4 of Section 20, Township 15 North, Range 12 East, of the 6th P.M., Douglas County, Nebraska, more particularly

described as follows:

Commencing at the Southwest corner of Lot 5, Block 8, Meadow Lane Second Addition; thence S00° 34'28"W (assumed bearing) along the Easterly right-of-way line of 120th Street, a distance of 159.39 feet to the Point of Beginning; thence N58° 53'46"E, a distance of 310.03 feet, to the Southeast Corner of Lot 3, Block 8, Meadow Lane Second Addition; thence N89° 49'54"E, along the South line of said Block 8, Meadow Lane, Second Addition, a distance of 46.16 feet to the Southwest corner of Lot 2, Block 8, Meadow Lane Second Addition; thence S57° 27' 49"W, a distance of 370.10 feet, to a point on the Easterly right-of-way line of 120th Street; thence N00° 34' 28"E, along said Easterly right-of-way line of 120th Street, a distance of 38.75 feet to the Point of Beginning.

Said City shall cause any trench made on aforesaid realty to be properly refilled, and shall cause grass seed to be sown over said trench, and shall cause the premises to be left in a neat and orderly condition. This easement is also for the benefit of any contractor, agent, employee and representative of the City in any of said construction and work.

Said Grantor(s) for himself or themselves and his or their heirs, executors and administrators does or do confirm with the said City and its assigns, that he or they, the Grantor(s) is or are well seized in fee of the above described property and that he or they has or have the right to grant and convey this easement in the manner and form aforesaid, and that he or they will, and his or their heirs, executors and definition administrators, shall warrant and defend this easement to said City and its assigns against the lawful claims and demands of all persons. This easement runs with the land.

The consideration recited includes damages for change of grade, if any, and any and all claims for damage arising from change of grade or grading are hereby waived.
