Lots 70 through 81, inclusive, Wedgewood Phase III Replat, being a replat of all of Lots 53 through 65, inclusive, together with a part of Lots 66, 67, Outlot 10 and Outlot 11, all in Wedgewood Phase III, an Addition to the City of Omaha, Douglas County, Nebraska, as surveyed, platted and recorded (according to the plat recorded on August 5, 1976 in the office of the Register of Deeds of Douglas County, Nebraska in Book 1550 of Deeds at Page 252).
