



**FIRST AMENDMENT TO AMENDED AND RESTATED DECLARATION  
OF COVENANTS, CONDITIONS, RESTRICTIONS  
AND EASEMENTS OF WEST SHORES, A SUBDIVISION  
IN DOUGLAS COUNTY, NEBRASKA**

THIS FIRST AMENDMENT (the "First Amendment to the Declaration") to the Amended and Restated Declaration of Covenants, Conditions, Restrictions and Easements of West Shores, a subdivision in Douglas County, Nebraska, dated January 15, 2013, and recorded on January 18, 2013 as Instrument No. 2013006361 of the Miscellaneous Records of the Register of Deeds of Douglas County, Nebraska (the "Declaration"), is made as of January 1, 2018 (the "Effective Date") by the Owners of not less than 75% of the Lots covered by the Declaration as set forth in Exhibit "A" attached hereto.

**WITNESSETH:**

WHEREAS, the Declaration and the First Amendment to the Declaration applies to the following described real property:

Lots 1 through 177, 180 through 242, and 246 through 294 in West Shores; Lot 1, West Shores Replat 2, being a replat of Lots 178 and 179 West Shores, a Subdivision in Douglas County, Nebraska (the "Property").

WHEREAS, the Owners of not less than 75% of the Lots covered by the Declaration desire to amend the Declaration and make the Property subject to the following amendments to the covenants, conditions, restrictions and easements set forth in the Declaration:

NOW, THEREFORE, pursuant to Article V (2) of the Declaration, the Owners of not less than 75% of the Lots covered by the Declaration as set forth in Exhibit "A" attached hereto, hereby declare that all of the Property hereinabove described shall be held, sold and conveyed subject to the following amendments to the easements, restrictions, covenants and conditions set forth in the Declaration and as amended herein, for the purpose of protecting the value and desirability of, and which shall run with all of said Property, and shall be binding on all parties having any right, title or interest in said Property or any part thereof, and their heirs, successors and assigns, and shall inure to the benefit of each owner thereof.

The Declaration is amended as follows:

1. Article I, Paragraph 3 shall be amended in its entirety to read as follows:

As to Lots 1 through 177, 180 through 242 and Lot 1, West Shores Replat 2, being a replat of Lots 178 and 179, West Shores (Lots 1 through 242), except as otherwise provided herein, no part of any residence may be erected or maintained on any of such Lots nearer to the front street right-of-way ("R.O.W.") than fifty (50) feet, nor nearer to the rear Lot line than seventy-five (75) feet, nor nearer to the side Lot line than ten (10) feet. As to Lots 246 through 294, except as otherwise provided herein, no part of any residence shall be nearer to the front street right-of-way ("R.O.W.") than fifty (50) feet, nor nearer to the rear lot line than twenty-five (25) feet, nor nearer to the side Lot line than seven (7) feet. Provided, however, that Declarant shall have and does hereby reserve the right with the consent in writing of the record owner of the fee simple title to any such Lot, to change any building line on any such Lot or Lots, so long as the change conforms to the Douglas County, Nebraska Zoning Ordinances.

2. Article I, Paragraph 7(a) shall be amended in its entirety to read as follows:

- a. The first 40 feet of the rear lot line from the water's edge must remain in sand for lake lots.

3. Article I, Paragraph 15 (only the opening paragraph) shall be amended in its entirety to read as follows:

All fences and landscaping must be approved by the (DRB) or its assigns. Fence types not allowed are wood or chain link. Fence types allowed are iron, metal, or PVC. Fences are allowed only on side yards from the front dwelling line to no nearer than 75 feet from the rear lot line, except Lots 246-294 the fence may go to the rear lot line and except for fences which are installed to enclose an in ground swimming pool (the "Pool Fence") which is constructed on the lot and which Pool Fence and the related pool improvements shall be subject to the following requirements:


4. Article I, Paragraph 15(h) shall be amended in its entirety and restated as follows:

Except for Lots 246-294, the closest pool can be from the side yard lot line is 20' and from the rear lot line is 60'. For Lots 246-294, the closest the pool can be from the side yard lot line is 10' and from the rear lot line is 25'.

5. Except as otherwise amended herein, all of the terms and conditions of the Declaration shall remain in full force and effect as stated.

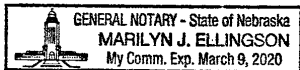
