RIGHT-OF-WAY EASEMENT

THIS INDENTURE, made and entered into this 26th day of August, 1957, by and between FRANK A. PEDERSEN and

ZONA E. PEDERSEN, husband and wife, parties of the First Part, and  
SANITARY AND IMPROVEMENT DISTRICT NO. 15 OF DOUGLAS COUNTY, NEBRASKA,  
Party of the Second Part,

TENNESSEE: That,

The parties of the First Part are the owners of the North Half  
of the Northwest Quarter of Section 32, Township 15 North, Range 12 West  
of the 6th P. M., Douglas County, Nebraska, and have a good and valuable  
consideration, receipt of which is hereby acknowledged, does hereby grant  
and convey to the Party of the Second Part a perpetual easement, right and  
privilege to construct, maintain and operate a sewer and appurtenances  
thereon over and across the Easterly portion of said property, the said line  
to be more particularly described as follows:

Commencing at a point on the East line of the Northwest  
Quarter of said Section 32, approximately 363 feet  
South of the Northeast corner thereof, thence a distance  
of approximately 296 feet South 67° 58' West; thence a  
distance of approximately 689 feet South 33° 27' West;  
thence a distance of approximately 32° 65 feet South 31°  
36' and 30" West to a point on the South line of the  
North Half of said Northwest Quarter approximately 821.3  
feet West of the East line of said Northwest Quarter.

The exact location of said line shall be fixed by the engineers for the  
District at the time of installing the sewer.

The agents, employees and contractors of the Party of the Second  
Part shall have the right of ingress to and egress from the said North Half  
of Northwest Quarter of Section 32, for the purpose of constructing, main-  
taining and repairing said sewer line, including manholes and appurtenances.

The said sewer line shall be buried beneath the surface of the ground and  
all ditches made in the installation, repair and upkeep of said sewer line  
shall be refilled by the Party of the Second Part and any trees or shrubberies  
removed or damaged in the course of construction, maintenance or repair shall  
be replaced by the Party of the Second Part.
