

AGREEMENT

It is hereby agreed between Royalwood Estates, Inc. (herein called Royalwood) and Omaha Public Power District (herein called District) as follows:

1. District hereby releases all utility easements under, upon or over the 5-foot wide strips of land adjoining the side and rear boundary lines of Lots 183, 184, 185, 186, 187, 188, 189, 190, 191, 192 & 193, all in Westwood Terrace, a subdivision in Douglas County, Nebraska, said easements having been granted by instrument dated July 28, 1961 and recorded August 1, 1961 in Miscellaneous Book 368 at Page 361 in the office of the Register of Deeds of said county.

2. District hereby releases all easement rights over, under and upon vacated Spring Street from the East line of 118th Street running Easterly to the West line of 116th Street in Douglas County, Nebraska; said easement having been originally reserved to District by action and resolution of the Board of County Commissioners of Douglas County, Nebraska, recorded October 24, 1961, in Miscellaneous Book 371 at Page 379 in the office of the Register of Deeds of Douglas County, Nebraska.

3. District, as successor to Nebraska Power Company, hereby releases all easement rights acquired by reason of contract dated October 31, 1929, recorded December 4, 1929 in Miscellaneous Book 90 at Page 17 in the said office of the Register of Deeds.

4. Royalwood, being the owner of all the following described real estate, hereby grants to District, its successors and assigns, a perpetual license and easement to erect, operate, maintain, repair, replace and renew underground cables, conduits or other instrumentalities, poles with necessary supports, sustaining wires, crossarms, guys and anchors, and other instrumentalities for the carrying and transmission of electric current for light, heat and power over, under and upon 5-foot wide strips of land adjoining the rear and side boundary lines of the following lots:

Lots 300 through 314, both inclusive, in Westwood Terrace Replat, a subdivision in Douglas County, Nebraska.

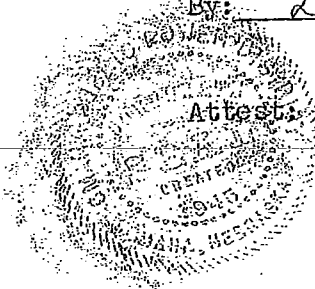

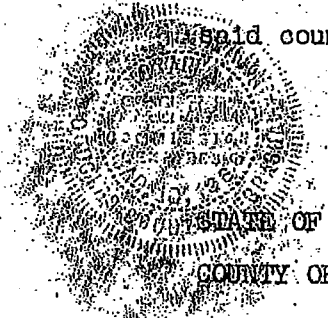
