Dodge, his wife, to waive, release and discharge ~~in whole~~ said Lots in Westbrook Addition to Omaha, Douglas County, Nebraska from the provision of said deed providing for a reversion of title to said grantors upon violation of any of the conditions or restrictions therein contained.

NOW, THEREFORE, in consideration of One Dollar (\$1.00) in hand paid, receipt of which is hereby acknowledged, and other valuable consideration, the said N. P. Dodge, Jr., and Laura W. Dodge, his wife, do hereby waive and release their right to a reversion of the title to said lot~~s~~ as provided in their deed, and said grantors hereby release and discharge said property from such provision for reversion.

This instrument is intended to release and discharge said property from the provision for reversion contained in said deed only, and does not waive, release or discharge said property from the conditions and restrictions upon same as fixed and provided for in said deed and as provided to run with the land conveyed in same.

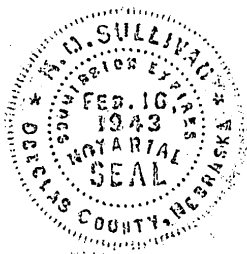
