# A RESOLUTION APPROVING STREET NAMES CHANGES IN WHISPERING OAKS SUBDIVISION AND WHISPERING OAKS SUBDIVISION, PHASE 2.

- WHEREAS, on October 9, 2017, the Council Bluffs City Council adopted Resolution No. 17-219, which granted final plat approval for Lots 1 through 123, and Outlot 'A', Whispering Oaks Subdivision (see Attachment A). The street names listed in this subdivision include Ash Court, Cypress Street, Hawthorn Boulevard, Forest Glen Drive, Oak Court, Spruce Lane and Whispering Drive; and
- WHEREAS, on October 23, 2017, the Council Bluffs City Council adopted Resolution No. 17-228, which granted final plat approval for Lots 124 through 150 and Outlot 'A', Whispering Oaks Subdivision, Phase 2 (see Attachment B). The street names listed in this subdivision include Forest Glen Drive, Linden Court and River Birch Court; and
- WHEREAS, all landowners in the Whispering Oaks Subdivision and Whispering Oaks Subdivision, Phase 2 were notified of the proposed street name changes and were given an opportunity to express their views to the Council Bluffs City Council; and
- WHEREAS, following a public hearing on June 11, 2018, the Council Bluffs City Council determined it's in best interest of the health, safety and general welfare of the citizens of Council Bluffs to rename the following streets in Whispering Oaks Subdivision and Whispering Oaks, Subdivision Phase 2 as stated below:
