DECLARATION OF COVENANTS

shall hereafter be held, transferred, sold, conveyed, and occupied subject to the following restrictions, to-wit:

- Any dwelling constructed upon any of the aforesaid lots shall face toward Chaput Drive adjoining said lots on the south.
- 2. Any garage placed upon any of the aforesaid lots except Lots 132 and 133 shall be accessible only by a driveway connecting onto Chaput Drive.

These covenants shall run with the land for a period of 30 years from the date hereof and shall be enforceable by any owner of property within Lots 129 through 147, both inclusive, Whispering Timbers Estates.

These covenants shall be in addition to and not in replacement of any restrictions, covenants or conditions presently existing with respect to the aforesaid real estate.
