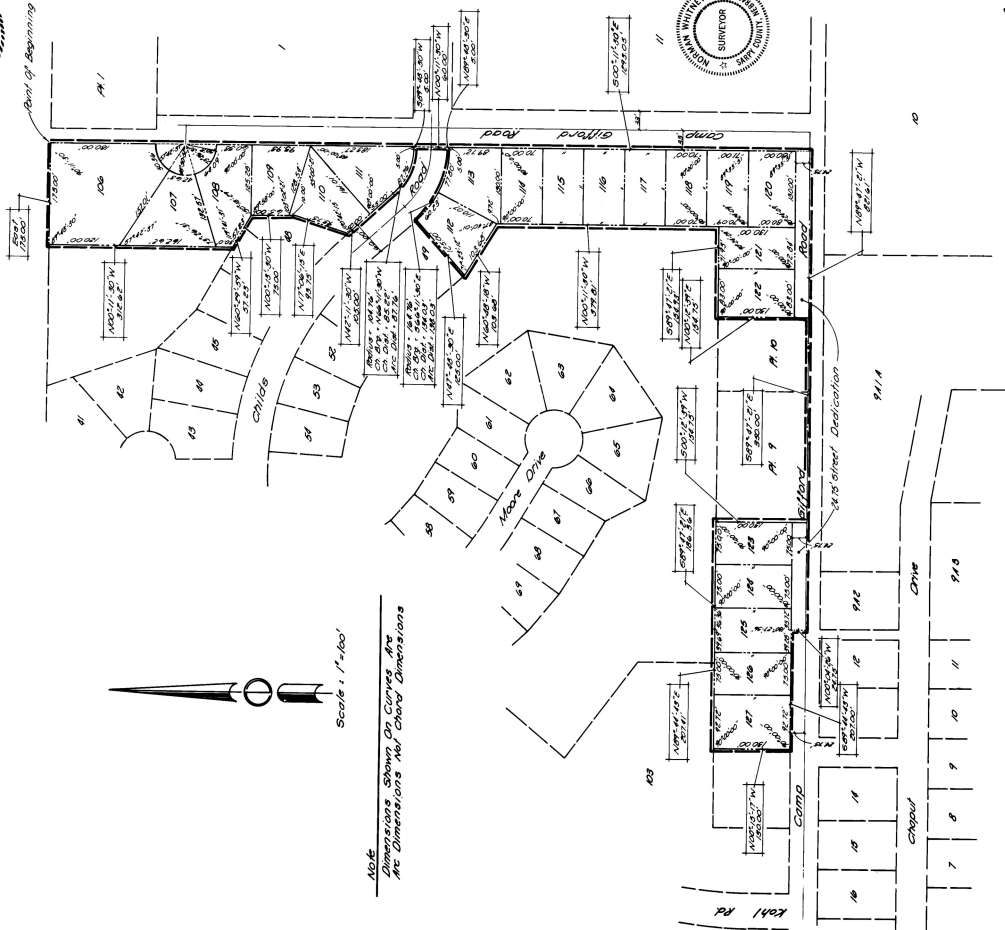


PHASE 3 WHISPERING TIMBER ESTATES
