

LEGAL DESCRIPTION RIGHT-OF-WAY DEDICATION SOUTH HWS CLEVELAND BOULEVARD

Part of Lots 284 thru 288, inclusive, Whitehawk (lots 234 thru 725, inclusive and Outlot "D"), a subdivision located in the East ½ of Section 6, Township 14 North, Range 11 East of the 6th P.M., Douglas County, Nebraska, more particularly described as follows:

Beginning at the Northwest corner of said Lot 284, Whitehawk (Lots 234 thru 725, inclusive, and Outlot "D"), said point also being the point of intersection of the Southerly right-of-way line of Weir Street and the Easterly right-of-way line of South HWS Cleveland Boulevard; thence S84°59'06"E (assumed bearing) along said Southerly right-of-way line of Weir Street, said line also being the Northerly line of said Lot 284, Whitehawk (Lots 234 thru 725, inclusive and Outlot "D"), a distance of 35.52 feet; thence Easterly along said Southerly right-of-way line of Weir Street, said line also being said Northerly line of Lot 284, Whitehawk (Lots 234 thru 725, inclusive, and Outlot "D") on a curve to the left with a radius of 450.00 feet, a distance of 70.13 feet, said curve having a long chord which bears S89°26'59"E, a distance of 70.06 feet; thence S86°05'07"W, a distance of 93.56 feet :thence S41°50'52"W, a distance of 7.16 feet; thence Southerly on a curve to the right with a radius of 1035.57 feet, a distance of 131.30 feet, said curve having a long chord which bears S01°22'51"E, a distance of 131.22 feet; thence S05°00'54"W, a distance of 183.10 feet; thence Southerly on a curve to the left with a radius of 465.00 feet, a distance of 64.78 feet, said curve having a long chord which bears S01°01'26"W, a distance of 64.73 feet; thence S02°58'02"E, a distance of 104.79 feet to a point on the South line of said Lot 288, Whitehawk (Lots 234 thru 725, inclusive and Outlot "D"), said point also being on the North right-of-way line of "Q" Street; thence S87°01'58"W along said South line of Lot 288, Whitehawk (Lots 234 thru 725, inclusive, and Outlot "D"), and also the South line of said Lot 287, Whitehawk (Lots 234 thru 725, inclusive, and Outlot "D") said line also being said North right-ofway line of "Q" Street, a distance of 33.92 feet to the Southwest corner of said Lot 287, Whitehawk (Lots 234 thru 725, inclusive, and Outlot "D"), said point also being the point of intersection of said North right-of-way line of "Q" Street and said Easterly right-of-way line of South HWS Cleveland Boulevard: thence Northerly along said Easterly right-of-way line of South HWS Cleveland Boulevard, said line also being the Westerly line of said Lot 287, Whitehawk (Lots 234 thru 725, inclusive, and Outlot "D") on a curve to the right with a radius of 350.00 feet, a distance of 41.30 feet, said curve having a long chord which bears N01°38'06"E, a distance of 41.27 feet; thence N05°00'54"E along said Westerly line of Lot 287, Whitehawk (Lots 234 thru 725, inclusive, and Outlot "D") and also along the Westerly line of said Lots 286, 285 and 284, Whitehawk (Lots 234 thru 725, inclusive, and Outlot "D"), said line also being said Easterly right-of-way line of South HWS Cleveland Boulevard, a distance of 460.71 feet to the point of beginning.

Said right-of-way dedication contains an area of 0.222 acres, more or less.
