WHEREAS, Whitehawk Development, LLC, a Nebraska limited liability company ("Whitehawk"), executed that certain Declaration of Covenants, Conditions, Restrictions and Easements of Whitehawk, a subdivision in Douglas County, Nebraska, dated March 24, 2004, and recorded April 8, 2004, as Instrument No. 2004044720, in the Miscellaneous Records of the Register of Deeds of Douglas County, Nebraska ("2004 Declaration"), which encumbered the following described real estate:

Lots 284 through 720, inclusive, in Whitehawk, a subdivision, as surveyed, platted and recorded in Douglas County, Nebraska; and
