I, William L. Rynearson, being first duly sworn on oath, depose and state that I am a registered land surveyor (L.S. #63) in the State of Nebraska; that I prepared the plat of Wilson & Mossman's Florence Addition (4th Platting) in the Southeast 1/4 of Section 29, T 16 N, R 13 E, of the 6th P.M., Douglas County, Nebraska; that some words and numbers used in the Surveyor's Certificate and on the plat as filed are in error; and should read as follows:

"I HEREBY CERTIFY that I have accurately surveyed and staked, with iron pipe, all corners of all lots, streets and angle points, and ends of all curves in Wilson & Mossman's Florence Addition (4th Platting), Lots 1 through 10, inclusive, Block 5; Lots 1 through 20, inclusive, Block 4; Lots 1 through 14, inclusive, Block 6; and Lots 1 through 2, inclusive, Block 7, being a replatting of parts of Blocks 201, 202 and 203, Florence, in the Southeast 1/4 of Section 29, T 16 N, R 13 E, of the 6th P.M., Douglas County, Nebraska; to-wit: Beginning at the Northwest corner of Lot 1, Block 3, Wilson & Mossman's Florence; thence N 0° 12' W, 276.75 feet; thence N 83° 27' 40" E, 234.88 feet; thence N 80° 47' 50" E, 487.84 feet; thence N 2° 18' 10" E, 141.85 feet; thence on a curve to the left (radius being 195.15 feet) for a curve distance of 10.22 feet; thence N 8° 25' 50" W, 50.0 feet; thence on a curve to the right (radius being 245.15 feet) for a curve distance of 52.18 feet; thence N 3° 45' 50" E, 143.82 feet; thence N 34° 33' 50" E, 22.20 feet; thence S 67° 34' 10" E, 170.0 feet; thence S 22° 25' 50" W, 5.0 feet; thence S 67° 34' 10" E, 255.0 feet; thence S 22° 25' 50" W, 745.0 feet; thence West and along the North R.O.W. line of Read Street, 133.73 feet; thence N, 79.22 feet; thence N 22° 25' 50" E, 44.11 feet; thence West, 766.63 feet to the point of beginning. (North R.O.W. line of Read Street assumed East-West in direction.)"

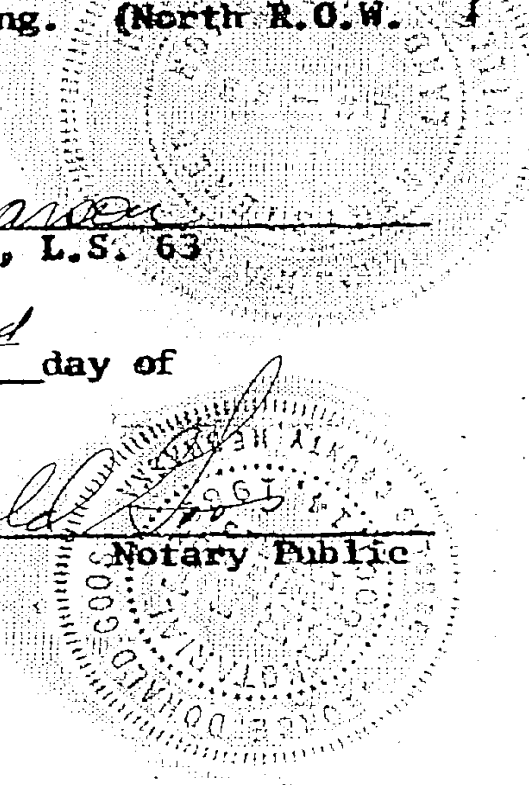
