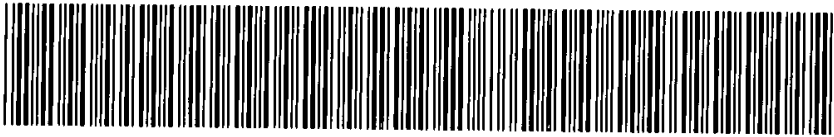

AMENDMENT TO THIRD AMENDED AND RESTATED PROTECTIVE COVENANTS FOR WOOD VALLEY

THIS AMENDMENT TO THIRD AMENDED AND RESTATED PROTECTIVE COVENANTS FOR WOOD VALLEY (this "Amendment") is made on the date hereinafter set forth by CR Investments, Inc., a Nebraska corporation and Celebrity Homes, Inc., a Nebraska corporation (together, "Declarant").

RECITALS

- A. On January 19, 2016 a document entitled Amended and Restated Protective Covenants for Wood Valley (hereinafter the "Declaration") was recorded with the Douglas County, Nebraska Register of Deeds of as Instrument No. 2016004189 against the following legally described property:

Lots 96 through 130, inclusive, 192 through 223, inclusive, 268 through 271, inclusive, 299 through 314, inclusive, and 352 through 473, inclusive, all in Wood Valley, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska; and Lots 1 through 66, inclusive, and 75 through 99, inclusive, Wood Valley Replat Two, all in Wood Valley, a subdivision as surveyed, platted and recorded in Douglas County, Nebraska.

- B. Paragraph 19 of the Declaration provides that for a period of ten (10) years the Declarant has the exclusive right to amend, modify or supplement any portion of the Declaration, including the right to detach any lots from the Declaration.

NOW, THEREFORE, Declarant hereby declares the Declaration shall be amended as follows:

1. Detachment of Lots. Pursuant to the provisions of Paragraph 19 of the Declaration, the Declaration is hereby amended to remove/detach the following legally described property from the Declaration, which real property is owned by CR Investments, Inc., one of the Declarants:



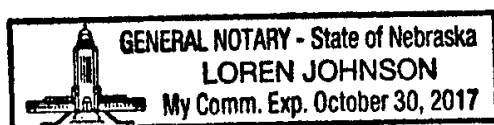
